## Libraries Build Communities Report of the President

As my whirlwind year as President of the Canadian Library Association draws to a close, I wish to thank the membership for bestowing on me the honour and the responsibility of representing the Canadian library community within and beyond our borders.

In my capacity as CLA President I spent a great deal of time on the road and in the air, traveling widely to connect with library colleagues and trustees and to raise the profile of our Association throughout Canada, the United States and even internationally.

This exchange afforded me the opportunity to provide details about my presidential theme: Retain – Recruit – Restructure: Regenerating the Library Community, and to listen and learn about issues and trends affecting the overall library community.

Being able to visit library schools across Canada was a major highlight of my tenure. I spoke to library science and library technician students about the value of membership in CLA and about current trends in the library profession. I was able to tell the students that they have every reason to feel optimistic about their futures in their chosen field. With more librarians and library technicians in the workforce either approaching or at retirement age, never has there been a better time to enter this profession. The future is particularly bright for those graduates who aspire to library management and leadership positions.

Some of the other initiatives I am most pleased about include the new design for our Web site, which is currently in progress. Consultation with the library community about what they would like to see in a revamped Association Web site will be an important part of ensuring a relevant and dynamic communication tool for the membership.

Solidifying our relationship with the provincial library associations was enhanced with our new involvement as a content provider in The Partnership's Education Institute. The Partnership is a national network of provincial and territorial library associations, and CLA looks forward to its participation in helping to offer educational opportunities for library workers and trustees.

Work has also begun on developing a national summit on human resources, based on the work of the 8Rs Research Team. Plans are well underway and we anticipate that the summit will take place in January 2008, in conjunction with OLA's Super Conference.

Sincere thanks go to my Board of Trustees at the Edmonton Public Library for supporting me in my role as CLA President, and also the Executive Team and staff at EPL. I owe them a debt of gratitude for allowing me the comfort level of knowing that the Library was in good hands while I was away on CLA business. I deeply appreciate their hard work and dedication during the past year and beyond.

It was wonderful to be able to work with a dedicated Executive Council which always had the best interests of the membership at heart. I also wish to acknowledge the efforts of the CLA administrative staff, a fine bunch who keep the wheels turning in the day-to-day operations of the Association.

The Canadian Library Association is well-positioned to build for the future and I look forward to continuing to work towards the betterment of our Association with incoming President Alvin Schrader and Vice-President/President Elect Ken Roberts.

## Activities Report June 2006 ~ June 2007

One of the arts of operational management is balance: between stability and advancement; between preserving the past and letting it go; between the tried-and-true, and beta-testing and innovation.

CLA's operational departments came down on different trays of the balance scales this year. Planning and implementation of conference 2007 has been relatively stable, and not just in comparison to the creativity of 2006. The peak of instability in the membership department was also reached in the previous year when a new program was initiated; activity on that project, and thus in that department, gradually tapered down into steady state this year.

Yet in advocacy and external relations, the situation was far from calm. CLA undertook and delivered on two major activities while continuing to monitor and be involved in ongoing issues. In both communications and in serving the professional community, it was a mix: two new projects were initiated that will not bear fruit until 2007-2008; and two long-standing innovations were wrapped up after intense final pushes.

In 2004, CLA members defined the thrusts of their association to be, in priority, advocacy and continuing professional development. CLA's Executive Council defined four strategic initiatives, again in priority, and CLA's operational activities are designed to move on these fronts.

#### Advocacy and External Relations

CLA undertook two major activities to represent the voice and view of library users and librarians in 2006-2007.

At the 2006 Annual General Meeting, the membership voted to oppose the "Captain Copyright" initiative of Access Copyright (see Resolution 2006-4). Supported by the Copyright Working Group, CLA President Linda Cook led communication with Access Copyright, expressing the library community's concerns with Captain Copyright. Ultimately, Access Copyright closed the Captain Copyright Web site.

Building on an earlier relationship established by Ottawa Public Library, CLA worked with the Canadian Space Agency to create essay contests to promote reading among children by getting them to imagine a visit in space with Canadian astronaut Steve MacLean. This culminated in an event at which Dr. MacLean and the rest of the space shuttle Atlantis crew presented contest winners with their prizes. The event attracted MP Colin Carrie, parliamentary secretary to the Minister of Industry, and a representative of the United States government as well as senior officials from the Space Agency; and won an international award for community relations.

Advocacy work continued on files such as copyright, access to information for the print-disabled, and library services for aboriginal populations. For example, on copyright, CLA met with Minister of Canadian Heritage Bev Oda, her parliamentary secretary, the chairs of the Industry and Heritage committees, and senior government officials to press the case for users rights. Meetings on access to information for the print-disabled involved MPs, an advisor in the Prime Minister's Office, and senior officials in the department of Canadian Heritage. CLA has met with MPs from all three parties within the past year to discuss library services for aboriginal populations.

CLA is partnering with Association pour la science et les techniques de la documentation (ASTED) to create a new foundation for supporting international librarianship through participation in International Federation of Library Associations' conferences.

Future human resources in the library community continues to be of interest to members. CLA published the Cultural Human Resources Council's *Training Gaps Analysis - Librarians and Library Technicians* as a companion report to the 8Rs Team's ground-breaking work *The Future of Human Resources in Canadian Libraries*. The CLA President's Council on the 8Rs is wrapping up its work by encouraging the creation of National Summit on Library Human Resources, scheduled for Toronto in January 2008.

#### Continuing Professional Development

CLA's 2006 Conference was both an educational and financial success despite the unprecedented challenge of relocation because of a labour dispute at the original venue. Due to extraordinary efforts by CLA staff and flexibility by exhibitors and delegates, CLA was able to hold true to the values of the library community and still create a positive learning and marketing experience for participants.

For 2007, CLA is partnering with the Atlantic Provinces Library Association and the Newfoundland and Labrador Library Association. There is significant excitement as CLA returns to St. John's for the first time since 1969.

As a preconference session to the 2006 Conference, CLA's Action for Literary Interest Group spearheaded a highly successful second National Summit on Libraries and Literacy. The Summit was able to bring together adult learners, literacy workers and librarians to review developments since the first Summit and to build networks for future collaborations. Its reports are available on CLA's Web site.

CLA's flagship magazine *Feliciter* continued to provide top-quality professional articles for information-sharing. The blend of articles on specific themes (e.g. outreach, school libraries) combined with overarching topics (technology, risk management) and practice-setting specific stories (small libraries, special libraries) has proven to be both educational and entertaining.

Access to books on librarianship and library services published by the American Library Association was streamlined in early 2007 through the introduction of on-line ordering.

CLA has accepted an invitation from The Partnership to contribute programming to its Education Institute, and will be working with CLA units like divisions, interest groups and committees to identify and fill professional development needs.

#### **Member Services**

In 2005-2006, CLA undertook a partnership with Canada Post and ASTED to revamp the operational aspects of the Library Book Rate (LBR). Prior to this project, Canada Post had no database of libraries eligible for the Rate, and no precise usage figures. Part of CLA's role was to create the database and (using Canada Post regulations) approve the libraries eligible to access the LBR. In 2006-2007, more than 2,000 applications later, the LBR database exists; all shipments using the Rate are done by electronic shipping tools including a barcode; and usage data is being gathered. The goal is to demonstrate the LBR's importance to public, academic, school and special libraries to public policy makers. The Rate itself has been extended to January 2008.

CLA continues to participate in the Young Canada Works program, and in 2006 created over 120 summer jobs and four internships in Canadian libraries.

Members had requested that CLA investigate and implement electronic voting in CLA elections. A pilot project in April 2006 led to full-scale implementation for 2007. The voting system also encourages awareness of the other membership features available in the members-only section of the CLA Web site.

CLA continues to wait for the federal government to invest its promised \$1 million per year for three years to test the proposed National Network for equitable library service for the print-disabled; however, in preparation for that day, CLA formed an Interest Group on Library Services to Individuals with Print Disabilities.

#### Communications

CLA's Web site has served the association well, but needs some serious attention. Following an analysis by members of the Member Communications Advisory Committee in early 2006, CLA's Executive Council charged staff with investigating options for renewing CLA's web presence. After work to define CLA's needs and a call for proposals over the fall, Executive Council authorized a budget expenditure in February 2007 to fund a Web site rebuild. Subsequently, software has been purchased; an advisory task force of members has met; and staff have been assigned to create a new Web site.

CLA's electronic newsletter CLA Digest began as a plain-text e-mail with links to expanded articles on the Web site, with the plan to upgrade it at some point. The new-look Digest debuted in April 2007 with a sharper image and expanded functionality.

#### **Internal Operations**

#### Governance

CLA started the 2006-2007 year with a seven of the 11 members of Executive Council being new to Council, resulting in both fresh energy and a significant learning curve for the new team. Again this year, Executive Council was confronted with an issue that involved core principles of librarianship, and used those principles to chart an effective course. Members can be proud of their leaders' principle-based approach.

#### Finances

Through one-time revenue resulting from the sale of an asset, a conference that generated more revenue than planned, and a tight rein on expenses, the planned operational deficit of \$54,000 was turned into a surplus of \$116,000. This has allowed CLA's unrestricted reserves to grow from about 15 percent of annual revenue in 2002 to about 22 percent in 2006. While this is still below a safe minimum of 25 percent, it does allow CLA to make strategic investments in projects like the Web site rebuild. The complete Audited Statements are included in this Annual Report.

#### Staff

CLA was well-served again this past year by staff who are dedicated to serving members and the library and information community. They demonstrate their passion for librarians, trustees and Master and library technician students, and suppliers to the library community by going the extra mile again and again: "not in my job description" does not seem to be in their vocabulary. I am honoured to work with them to serve Executive Council and all the members of the Canadian Library Association.

THE SPECIAL PURPOSE FUNDS have been established by groups of members, divisions and others for specific projects and purposes.

# SIGNIFICANT ACCOUNTING POLICIES

AMORTIZATION

## Division Reports June 2006 ~ June 2007

#### CANADIAN ASSOCIATION FOR SCHOOL LIBRARIES

Submitted by Sandra Hughes, President

#### CASL and CLA

As one of the Divisions, CASL works within the broader CLA structure while retaining its autonomy.

A CASL Strategic plan and annual budget were developed with the CASL executive and shared with the CLA Executive Council. A CASL Strategic Action plan was developed with the CASL executive and used to implement the Strategic Plan.

#### CASL submitted to CLA:

- 1. Call for More Research on School Libraries
  - a. Presentation at CLA Annual Conference June 2006 -

#### Challenges and Achievements: School Libraries in Canada

This presentation looked at what the Canadian School Libraries and Teacher-Librarians: Results from the 2003/04 Information and Communications Technologies in Schools Survey means to Canadian school libraries. It explored the challenges and the achievements this report reveals and their implications. It challenged the participants to help pursue further research into school libraries in Canada.

- b. Presentation to CLA Executive Council September 2006 emphasizing the need for further research into school libraries and requesting CLA support for this. Support in principal was given to pursue further research and bring a research proposal to Council for financial support.
- c. I submitted to CLA Executive Committee my concern regarding the 8Rs research being inadequate in regards to school librarians and requested in the minutes of the February 2007 Executive meeting that any further 8Rs research include School Libraries in a more thorough fashion.
- 2. Fall issue of Feliciter entitled School Libraries Vol.52 No.5 (2006): guest edited by Marlene Turkington and Sandra Hughes.
- 3. Membership Recruitment and Retention Plan Feb.-Dec. 2007

#### CASL EXECUTIVE ORGANIZATION AND OPERATIONS

The term of office of the CASL President was reviewed, and the decision was taken to propose to the membership amendments to the constitution and by-laws to enable a two-year term of office in line with the two-year terms common to the other CLA Division Presidents. The total time commitment for the individual accepting this responsibility was kept to four years by creating a rotation of the President-Elect and Past-President positions. This then created a situation where our executive council would have one less member. We decided to change the by-laws to increase the number of councillors to three to enable us to maintain a council of six members. The process for amending the constitution and by-laws was followed with the support of the CLA Executive Director and legal advice from CLA Parliamentarian Jim Lochrie. The changes will be taken to the CASL AGM in May 2007.

#### **PUBLICATIONS**

- Publications Editorial Board The Board presented its recommendations to CASL in June 2006, when the chair was passed from Gloria Hersak to Marlene Turkington. In January 2007 the chair passed to Sandra Hughes. A teleconference was held March 2007 and a face-to-face meeting is planned for St. John's in May 2007.
- 2. Achieving Information Literacy (AIL) The revision process has been initiated. French translation possibilities have been identified. Funding is still a concern.
- 3. Copyright monograph John Tooth has agreed to form a committee to begin work September 2007.
- 4. The CASL website has been re-created with a fresh new look by Richard Beaudry on the CLA server as a temporary vehicle to keep our communications open until the new CLA site is created. CASL is involved in the development of the CLA cite through the participation of Richard Beaudry in CLA's task force.
- 5. SLIC, our online journal, has been transferred to the CLA server by Richard Beaudry with ongoing communication with Judy Green and the CLA office to resolve problems as they arise.
- 6. SLIP/PIBS our school library information portal continues to be updated on a frequent basis. Information on how to access School District School Library related documents will be linked to so that even if they are not available in full text online researchers will be aware of their existence and how to access them.
- 7. CASL President's Update has been initiated as a regular feature for IMPACT as well as SLIC.

#### **NETWORKING AND LOBBYING**

- 1. CASL-PAC The Provincial Advisory Council is a critical part of CASL. It acts as a communication link between all of its members including the CASL Executive and the presidents or designates of the provincial and territorial school library associations. It also provides a framework for joint efforts on issues relevant to both national and provincial levels. This year CASL-PAC has had 4 teleconferences and will have a meeting in St. John's. Changes: action plan Role of Teacher-Librarian, Advocacy; Traditional CASL-PAC Breakfast changed to full morning meeting Friday May 25, with a 45-minute discussion session with school library leaders at the end of the morning.
- 2. CCSL Discussions were held with the Canadian Coalition for School Libraries at Word on the Street Sept.2006, and at the OLA Superconference Feb. 2007. A Parent Survey designed by Helaine Becker of the Ontario Coalition for School Libraries and based on AIL was offered to CASL for adaptation to all of Canada. This survey is meant to be used by parents and community members who are interested in how their school library is doing according to the standards. Sandra Hughes developed this Canadian version and it is to be mounted on the CASL website as an Advocacy item for downloading.
- 3. **CAP** Discussion with Ted Whiteland, President of Canadian Association of Principals, in February 2007 explored common areas of interest, particularly school library research and copyright. A CASL presentation to CAP Executive by Richard Beaudry April 10, 2007 in Vancouver was facilitated.
- **4. National Librarian and Archivist** Correspondence with Ian Wilson resulted in an up to date quote in support of school libraries for publication on CASL websites, in our newsletter and brochures and a clearer understanding of NSLD.
- 5. Media Awareness Network and the Canadian Council of Ministers of Education were approached regarding the need for more school library research.
- 6. A meeting was held with Education Institute (The Partnership) representative Liz Kerr.
- 7. TALCO (The Association of Library Coordinators of Ontario) meetings held every other month at the OLA office were attended. Greetings and CASL updates were given at each meeting.

#### PUBLIC IMAGE AND ADVOCACY

#### National School Library Day

National School Library Day and Canada Library Month were assigned to Councillor Mary Louise Mills. CASL member Ann O'Keefe and Mary Louise were on the CLA committee preparing for Canada Library Month 2007. To facilitate their work contacts were made with Ministers of Education across the country regarding support for the day.

#### **OLA** Superconference

The CLA booth at the Trade Show was staffed by CASL Executive members for the majority of the show. Many contacts were made and information shared in promotion of CASL.

#### Advocates for Canada's Children

The Canadian Association for School Libraries (CASL) is striving to ensure that all of the children in Canada have an opportunity to have school libraries, with appropriate resources and staffing to help them become life long learners.

Visit our poster session at the CLA Annual Conference to learn more about CASL, meet members of the executive, and discuss with them the needs of the school libraries in your province and Board. Achieving Information Literacy: Standards for School Library Programs, a nationally recognized and internationally acclaimed document, will be on display. CASLIS uses the strategic plan developed some years ago to direct our activities.

#### Strategic Objectives:

1. CASLIS will develop an active, diverse membership

We actively pursue students to become part of CASLIS: the Calgary chapter has a student who is organizing production of the 2007 CASLIS Directory as part of her coursework; the Toronto chapter extended invitations to programs to students at no cost; CASLIS Executive met with students from library schools.

This year's Award for Special Librarianship in Canada was awarded to Christine Corston and will be presented to her at the AGM.

2. CASLIS will develop and provide services that are meaningful to its members

#### COLLECTION DEVELOPMENT AND MANAGEMENT

With its terms of reference in mind, the Collection Development and Management Interest Group (CDMIG) has been involved in a number of interesting activities and projects in the last year.

#### Collections Pre-conferences

The collections pre-conference is an almost-annual event (it has been held every year since 2002, save for 2003) and has become the primary project for the CDMIG.

The 2006 pre-conference, entitled "Collections 2006: Collections, Communities, and the Future", was held on June 14, 2006 at the Wellington St. building of Libraries and Archives Canada. It was well attended, with over 70 people taking in several collections-themed presentations.

On May 23, 2007, the latest edition of the pre-conference, "Collections 2007: Reinvigorating Collection Development and Management", will be held at the INCO Centre on the Memorial University of Newfoundland. We believe that it will be as successful as earlier events, though the number of attendees will likely be a little less than in previous years.

Steps are underway to organize a pre-conference to take place before the 2008 CLA conference in Vancouver.

#### **CDMIG Award**

CDMIG members have developed a collections-themed award, the CLA/YBP Award for Outstanding Contribution to Collection Development and Management. This award is designed to "recognize an individual member in good standing of CLA who has made an outstanding local, national or international contribution in the field library collection development or management". YBP Library Services has very kindly provided a prize of \$1,000 to be awarded to the winner. The first presentation of the CLA/YBP Award for Outstanding Contribution to Collection Development and Management will be at the 2008 CLA conference.

#### Sponsoring Sessions at the CLA Conference

As in past years, the CDMIG will be a sponsor at the main CLA conference. This year, we will be sponsoring #37 Seeing Ourselves: Images of LGBT Families in Children's Books and #38 An Evidence-Based Approach to Defining a Core Journal Collection.

#### Other Projects

Other projects for the CDMIG include:

- Publishing the pre-conference papers. While this is slightly behind schedule, this project is still being worked on.
- Improving communication. For the most part, intra-group communication is carried out over email, primarily in email updates to members. This is OK but a more fluid form of communication is preferable. Perhaps the lists that CLA will be setting up in the summer will help. There may be a need for a collections-themed list or similar vehicle for communication that is Canadian-based; this doesn't necessarily have to be limited to CDMIG members (unlike other communication outlets) but perhaps it is something that the CDMIG can coordinate.
- Improving the Web presence for the CDMIG. This is tied to improving communication. A few members have been working on this since last year but there is more to do.

• Provide grants or scholarships for CDMIG members to attend professional development activities. This could focus on new collections workers, perhaps. Now that the award has in place, this could be a useful related step to work on.

  Coordinator, Health Sciences Library, Memorial University of Newfoundland. This session is an exciting continuing
  education opportunity for librarians.
- Organized a pre-conference workshop proposal to CLA 2007: How to Assess the Evidence: A Critical Appraisal Tool for Library and Information Research with Lindsay Glynn, Instruction Coordinator, Health Sciences Library, Memorial University of Newfoundland. (Workshop was subsequently cancelled due to low registration.)
- Successful submission of a conference session at CLA 2007: Evidence-Based Librarianship: A Toolkit for Public Libraries. This session will introduce a practical EBL toolkit tailored to public libraries. Speakers: Virginia Wilson, Coordinator, Saskatchewan Health Information Resources Partnership, Saskatoon, SK (and co-convenor of EBLIG) and Stephanie Hall, Chief Librarian, Powell River Public Library, BC.
- Creation of a wiki entitled *eblibrarianship:* the wiki of the Evidence Based Librarianship Interest Group (EBLIG) to facilitate interest group collaboration, sharing, and information access, as well as to be a means of communication: http://eblibrarianship.pbwiki.com/
- Promotion of international membership opportunities for EBLIG in CLA through the CLA IG web space, the EBLIG listsery, the eblibrarianship wiki, and the Evidence Based Librarians group on Facebook.
- EBLIG members edited and contributed to an EBL-themed issue of Feliciter.
- EBLIG members are participating as editors, on the editorial advisory board, and on the evidence summary team of the open access journal, Evidence Based Library and Information Practice.
- As a result of seeing a posting on the eblibrarianship wiki for the CLA session *Evidence-Based Librarianship:* A *Toolkit for Public Libraries*, Virginia Wilson and co-presenter Stephanie Hall have been invited to present a 1-hour audio conference for the Education Institute in the fall of 2007.

ETIG is sponsoring a pre-conference for CLA 2007 with CASLIS entitled *Getting to Library 2.0*. ETIG will again provide financial support to the ACCESS Conference, being held in Victoria in 2007.

#### Plans for 2007-2008

ETIG members will meet at CLA with a couple of important items on the agenda. One is a reconsideration of the standing budget, as several lines have not been used in years (in particular, the money set aside for ETIG workshops). It is also clear that ETIG is losing money (although not membership) each year. This will have to be addressed. Finally, the group will consider staggering the terms of the convenors so that there is continuation.

#### LIBRARIES IN COMMUNITIES

This interest group focuses on using community development approaches in communities and neighbourhoods to build inclusive and collaborative libraries. Concerned primarily with socially excluded communities and individuals the group focuses on the philosophies, strategies, empathies and self support that librarians need to reduce the rigidity of the relationships between socially excluded communities and the library.

Libraries in Communities was established at the Canadian Library Association's annual conference in 2006. The focus of the first year has been on recruitment and on disseminating information about community development in a library context. The convenor, Annette DeFaveri, has given a national audio conference through the Education Institute, and workshops in British Columbia to familiarize librarians with the concept and practise of community development work. The most interesting issue is defining community development as something more than developing our communities. Libraries have always worked to develop and support their communities, but with a community development approach we articulate a specific service model that emphasises a responsive, inclusive and needs-based library. At the heart of this service model is a focus on integrating community consultation and collaboration in to the library's planning process. Developing an inclusive library culture ensures that all members of our communities, including those that are socially excluded, benefit from the library's resources.

#### MONTREAL CHAPTER

- 1. The CLA Montreal Chapter participated in the national Librarians Run for the Cure team on Oct. 1, 2006. Ten local team members ran or walked the route in Montreal; Laura May represented the Chapter as our local team captain, and Jocelyne Andrews, Alexandra Yarrow and Pat Riva also attended.
- 2. The Chapter participated in the 23<sup>rd</sup> annual Christmas Fund-raiser for CODE, co-hosted by ABQLA, SLA and the Chapter. The event was held on Dec. 6, 2006 at the Fraser-Hickson Library and 65 people attended.

#### WORLD LIBRARIES

The Interest Group was asked by CLA to give advice about how to spend last \$14,000 of Tsunami Fund. After consultations with WLIG members, UNESCO, and representatives from organizations in Sri Lanka, the WLIG proposed giving \$7,000 to the National Institute of Library & Information Sciences (University of Colombo) to be spent on school libraries, and \$7,000 to the National Library and Documentation Services Board, where it would be directed to the Sri Lanka Libraries Disaster Management Committee and put toward public libraries.

The Group has approved budget for the following:

- Honoraria and speaker fees (local librarians with international work experience to speak at library schools in an effort to generate interest in issues related to international librarianship):  $6 \times $100 = $600$
- Publication of pamphlet: "Being Responsible Book Donors" (design, printing and postage): \$450
- Development of an International Work Experience database (presumably by a LIS student): \$300

One of the Group's submissions for CLA Conference sessions was granted, "The Grand Adventure: Canadian Library Works Go Abroad" with Sue Adams (Coady Institute, St. Francis Xavier University), Sybil Harrison (Hamilton Public Library, and recently returned from the United Arab Emirates), Larry McCallum (recently returned from the United Arab Emirates), Bob McKee (Chartered Institute of Library and Information Professionals, United Kingdom), and Janis Rapchuk (Canadian Women for Women in Afghanistan).

The WLIG seems to have become a touch-group for people from other countries interested in working in Canada, Canadians interested in international projects, and people interested in various aspects of international and multicultural librarianship.

Evette Berry, a WLIG member, interviewed Janis Rapchuk of Women for Women in Afghanistan and wrote an excellent article for Feliciter. The article appeared in the Vol. 52, No. 6 issue.

### Committee Reports June 2006 ~ June 2007

#### INTELLECTUAL PROPERTY AND PUBLIC ACCESS COMMITTEE

#### Copyright Working Group

The CWG drafted a letter regarding Captain Copyright in response to the resolution at CLA's general meeting in June. We believe that CLA's stand was instrumental in the eventual demise of Captain Copyright.

The Convenor of the CWG went to Ottawa for highly successful meetings on Feb. 14, 2007 with the Minister of Canadian Heritage, several other key MPs and with the two Director Generals responsible for copyright at both Canadian Heritage and Industry Canada. The meetings focused on fair dealing; technical protection measures; and crown copyright.

Work was done on putting together a Copyright Preconference which had to be abandoned when there was insufficient registration by the deadline.

#### Information Policy Working Group

The inaugural Information Policy Student Poster Display Travelling Exhibition wound up at the University of British Columbia in the last week of term in April. The five posters, from five different library schools, were displayed at each of the seven Canadian schools. These displays involved a great deal of effort from students, staff and faculty at each school and were very well received by each school. The schools have indicated to the committee that they would be pleased to participate in next year's display. Several sources within CLA eventually offered to defray the costs associated with shipping the posters but it appears that the schools, for this year at least, have absorbed these costs (for which the committee is grateful). No funding was directly available to support the student creators of the posters to get to Ottawa to present them: eventually about half were able to come and speak to their own posters — in the other cases, members of their school communities spoke on their behalf.

In 2006-2007, the Working Group is sorry to report that only The University of Western Ontario mounted its Information Policy course. Having ascertained this in advance, the Working Group decided to open the terms of its Poster Display at the Convention in Newfoundland to any student poster nominated by a school that has an Information Policy theme. Even so, there will be only three Information Policy posters on display this year: The University of Western Ontario, Dalhousie and Alberta. The Working Group Chair has been working with the student advisors and the students in efforts to assist all three students to obtain funding to get to Newfoundland to speak to their posters - to date, it would appear that two will be able to be there for certain. For the future, it would be wonderful to have CLA support these students on an ongoing basis. On the other hand, as mentioned, all seven schools have indicated their interest in hosting these three in the "follow-up" cross country tour in 2007-2008 which it is hoped the Working Group will organize on the model of this year's tour.

The Working Group has had some membership changes and will be welcoming new members in Newfoundland. Several members have expressed interest in using technology to join that meeting even though they will not be in Newfoundland. It will be very challenging to do, but we are investigating it.

As it has every year for the past three years, the Working Group proposed a session at the annual Conference. This year, spearheaded by Professor Sandra Toze from Dalhousie, the Committee program proposal was accepted without changes by the Conference Committee: "Does Privacy Place Limits on Collaboration" - with Sandra as Convenor and presenter, Carol Perry (Guelph) and Working Group Convenor Margaret Ann Wilkinson. Carol and Margaret Ann will present the results of two different new national surveys and Sandra will speak of the practical implications of collaboration.

The Working Group is a small one, and we have requested appointments of new members. Recently great concern has been raised within its membership over CLA's position concerning MNet at the CRTC and media concentration issues. One concern of the Working Group is that this issue was not canvassed with our Working Group before CLA took a position on it. Other concerns involve both the process by which the CLA position was arrived at generally and the merits of CLA's position. All these matters are on the Working Group's agenda for CLA.

Finally, I will be passing the "convenor" torch to another member after the May meeting.
