2008-2009 Report of the President

When I was elected President of CLA Stephen Abram warned me not to be too ambitious, that any President could only hope to accomplish one thing during the year's term. Wendy Newman added that she had been President the last time there was a change in Executive Director and that managing that change was an all-consuming task.

If my one accomplishment is to have hired Kelly Moore as Executive Director of CLA, then I have had a very good year. She started work the first day of the HR Summit last October and has become more confident and more impressive with each passing week.

But while a President might only accomplish one or two things, an organization such as CLA can stay fresh and relevant and creative when it harnesses the power of its membership and when it employs good staff. We are moving forward on a number of fronts.

As a result, I can tell you about more than a single accomplishment.

To me, one of the most impressive changes in CLA over the last several years is our increasing effectiveness when lobbying for issues of importance to our profession.

Rob Tiessen of the University of Calgary has done a stunning job chairing our Copyright Working Group, producing an excellent position paper related to the last version of a national copyright bill and preparing for the next version, expected to be tabled this coming fall. We have worked effectively with Impact Public Affairs to ensure that our positions on copyright and other issues are known on Parliament Hill. Kelly and I met with a senior staff member at Heritage Canada just over a week ago and heard our thoughts and feelings on copyright fed back to us as valid concerns.

Impact Public Affairs and Kelly and I have done, we believe, a good job of ensuring that Canadians also understand the value of libraries during tough economic times. I am probably the first CLA President in years to be heard on both the national radio and television news.

I have travelled the country during the past year and can tell you that many of the concerns raised at October's HR Summit resonate with our colleagues. There is surprisingly strong support for the concept of recertification and there is enthusiasm for breaking down the barriers between our current silos, allowing more career flexibility. There is also pride in the name librarian. Joanne Gard Marshall of the University of North Carolina told us last fall that, in one survey, over 90% of American librarians stated that they were either pleased or extremely pleased with their choice of profession. As she indicated, we need to celebrate this stunning finding.

CLA has made significant changes in our annual conference, with more to come. We are trying to place greater emphasis on new voices and the best possible ideas and concepts, instead of simply the best ideas that fit within a year's set theme.

We remain active and committed to the concepts of Intellectual Freedom. I entered into a debate regarding Internet Filtering that took place – and is still taking place – in Cambridge, Ontario when members of the public began to make pronouncements about what public libraries must do. As you may know, an MPP from the Cambridge area has sponsored a private member's bill that would require all Ontario public libraries to install filters. We will continue to monitor this bill and will fight it aggressively if it gains any momentum.

Several years ago our membership at a previous AGM asked their Executive Council to tell Heritage Canada that it felt the position of National Librarian should be filled by a professional librarian. When the position of Librarian and Archivist of Canada became vacant earlier this spring Executive Council decided that the existing motion is still valid. We immediately wrote to Heritage Canada and let them know that CLA strongly felt the Librarian and Archivist of Canada should be either a Librarian or an Archivist. As you know, the position was filled internally and was filled very quickly. While the new Librarian and Archivist of Canada is not a librarian or archivist, we will work with him to ensure that Library and Archives Canada remains relevant to our community.

Last year's AGM produced four resolutions from the floor, and I am pleased to report that all four were received by Executive Council and considered very carefully. I was directed, by Executive Council to act quickly on several of the resolutions and did so.

One of the privileges of being CLA President is the opportunity to attend the IFLA conference. Alvin was able to show to stunning pictures of South Africa at last year's AGM and John will be able to show you equally stunning pictures of Milan next year. As you know, I was able to attend IFLA without leaving the country or even the time zone where I live. Still, it was an honor to be the host country for IFLA librarians from around the world. Conversations at that conference reminded me of just how lucky we are to live and work in Canada.

I need to make sure that you all thank your Executive Council. They have been terrific. I have been a professional librarian in Canada for more than thirty years. The past two years have taught me that my own thinking about the profession has been too narrow and too confined to my own silo – public libraries. We are a richer profession than I knew and our ranks are peppered with strong and talented people I had never met.

One of these new friends has been last year's President, Alvin Schrader, and another is your incoming new President, John Teskey. I did not know John until just over a year ago but can tell you now that – between John and Kelly and your Executive Council and the staff of CLA- the organization is in good hands.

Activities Report June 2008 ~ June 2009

Executive Director Activities Report 2008-2009

2008 was a year of significant activities and significant changes for CLA.

One of the major events of 2008 for the Canadian library community was the opportunity to play host to the IFLA World Library and Information Congress in Quebec City. Nearly 4000 librarians and exhibitors from around the world gathered for this event, and over 600 Canadians were able to participate in this unique professional conference. CLA had representation on the National Organising Committee, and many of our members hold key volunteer positions within the IFLA governance structure.

In anticipation of the IFLA Congress, CLA worked with the Association pour l'avancement des sciences et des techniques de la documentation (ASTED) and other members of the library community to create **BiblioMondialis**, a national foundation with two main purposes. In the short term, it was to provide assistance to delegates from developing countries to attend the IFLA Quebec meeting. In future, it is intended to provide funds for Canadians to pursue international activities in librarianship, whether that be attending foreign national or international conferences or conducting research on issues related to international librarianship.

Prior to the IFLA Congress, the Bibliomondialis foundation raised over \$43 000. Money was disbursed to bring 8 delegates to IFLA Quebec; and there is now approximately \$10 000 remaining in the fund. CLA and ASTED are working to develop the criteria by which individuals may make future applications to the fund.

2008 saw a number of **staff changes** in the CLA office, with the departure of the Executive Director, the Webmaster, and the retirement (after 24 years!) of Executive Assistant Brenda Shields. This degree of turn-over, and the resultant impact on our corporate memory, has proved to be a challenge for staff as we moved into 2009. However, we also recognise that it gives us the opportunity to review some long-standing practices, and to implement changes where appropriate.

It has been a bit of a whirlwind since I arrived in the Executive Director's office at the beginning of October.

My first two days in the job coincided with CLA's hosting of the National Summit on the Future of Library Human Resources. It was an excellent introduction to many of the leaders of our community, and a chance to observe them working together to face the particular challenges of a rapidly changing workforce environment. Summit participants have agreed to tackle a number of key issues, and CLA will coordinate this on-going work.

One of the unanticipated but fascinating files which I have taken on is **Resource Description and Access (RDA)**, the next-generation cataloguing standard. CLA is a member of the Committee of Principals, the oversight body for the project, and is also a co-publisher of the RDA product. CLA members participate on the Joint Steering Committee (JSC, responsible for developing the RDA content), and are also engaged in providing comments on the draft text. They are holding workshops to introduce the product to the professional community and provide updates on its development. It is anticipated that RDA will be available for use by the end of 2009.

CLA has continued to work on a number of advocacy initiatives over the past year. We were pleased that Canada Post decided to maintain the **Library Book Rate** for 2009, with no increase in costs. We were also happy to support MP Merv Tweed (Brandon-Souris) on the introduction of his private member's bill to create legislation supporting the Library Book Rate. Past-President Barbara Clubb participated in the press conference introducing this bill. CLA continues to encourage members to sign petitions for Mr Tweed to present to Parliament.

With our government relations firm, Impact Public Affairs, we created an **Elections Toolkit** for members during the last federal election. The kit contained sample letters, questions to ask of riding candidates, and talking points on issues of particular importance to CLA members and our profession. The toolkit was one of the most-used elements of the CLA website.

We continue to meet with MPs, and officials and staff in federal government ministries to raise awareness of key issues, including copyright and infrastructure resources for libraries. We alre also working in concert with staff at Library and Archives Canada and the Canadian National Institute for the Blind on the development of the Initiative for Equitable Library Access.

I have had the priviledge of attending a number of **provincial association conferences**: the OLA Superconference (CLA President Ken Roberts and I gave a session on the HR Summit), the Alberta Library Conference (CLA had an exhibition booth to promote our 2010 National Conference in Edmonton), and the Manitoba Library Association conference (I was invited to give the closing keynote address).

Following up the recommendations of the Executive Council's Task Force on the Conference Program, CLA staff have been working on implementing changes to continue to **strengthen the CLA conference**. This year, we changed a number of elements including the composition of the Conference Program Committee and the submission process for sessions. We worked on presenting a revitalised Book Awards Ceremony, and expanded the Closing Ceremonies. We will be evaluating these changes, and look forward to introducing a few more new elements in Edmonton.

It has been an exciting and challenging first eight months on the job. I would like to thank all CLA members, and particularly members of Executive Council for your patience and support while I learn the ropes. And I would like to acknowledge and thank the CLA staff for breaking me in gently!

INVENTORY

INVESTMENTS

Inventory is valued at the lower of average cost and net realizable value.

Investments in mutual equities and bonds funds are recorded at market value.

AMORTIZATION

Amortization of capital assets, other than leasehold improvements and systems software, is calculated using the declining balance method. Amortization of leasehold improvements and systems software is calculated using the straight-line method. Amortization of other assets is calculated using the straight-line method. The rates are as follows:

REVENUE RECOGNITION

CANADIAN ASSOCIATION FOR SCHOOL LIBRARIES

CASL has continued to promote the interests of teacher librarians and school libraries across Canada. A president, I represented CASL and teacher librarians at CLA Executive meetings in September and February as well at the national conference in Montreal at the end of May 2009. I was part of a group of library stakeholders from across the country who met in Ottawa in October at the National Summit on Human Resources.

In 2008-09, I continued posting information and resources for both the SLIC and NSLD websites. Derrick Grose is the new editor of School Libraries in Canada (SLIC). After a delay of 8 months, I published my last edition of SLIC as editor in January 2009 and Derrick published his first edition in February 2009.

Donna Desroches from Saskatchewan and I continue to post information of interest to our membership on the CASL listserv. I continue to share information from the executive to our membership through the CASL listserv.

In 2008-09 we continue our policy of keeping in touch with provincial associations by subscribing to provincial listservs and passing along information. We post information to the CASL-PAC listserv so that we can keep in touch with provincial and territorial association executives across Canada.

I have expanded my role on the Teacher Librarian Ning by sharing administrative duties of the site with Dr. Joyce Valenza and other teacher librarians. It offers groups, discussions and forums for literacy experts to discuss school library related matters. Many teacher librarians across Canada have joined this network. http://teacherlibrarian.ning.com/

Sandra Hughes, our advocacy chair, has set up an Advocacy Blog for our members. She continues to work on it.

BC Literacy Forum

This online community offers literacy organizations, teachers, teacher librarians, parents and other stakeholders in literacy education in Canada to join together. It offers discussions, groups, resources, photos and videos.

Several members of the CASL executive continue to participate in this forum. http://www.bcliteracyforum.ca/

Advocacy

We continue to promote conferences and institutes across the country on the CASL website and listserv so that teacher librarians can meet and exchange information. Because of the ongoing economic downturn across North America, we have been vocal in responding to cutbacks to teachers librarians and services to school libraries across Canada, especially in the Maritimes.

We continue to meet by teleconference or face-to-face with CASL-PAC members to discuss advocacy issues.

CASL continues to work with the Canadian Library Month Committee to coordinate our National School Library day within the CLM activities. Seven provinces and 1 territory officially declared NSLD in October 2008.

John Tooth will be presenting a copyright monograph for school libraries in Canada that he has written on behalf of CASL at the National Conference in Montral.

We have formed an editorial board and have started writing the second edition of Achieving Information Literacy: Standards for School Libraries in Canada. We hope to have it ready for printing at the end of 2009.

CANADIAN ASSOCIATION OF PUBLIC LIBRARIES

As a strategic initiative, the CAPL Executive approved a new logo to replace the one that has been the face of the Division since 1994. Thanks to Partner Publishing for designing a logo that truly reflects a new image for Canada's public libraries. A CAPL banner with the slogan *Be the Difference* was also designed. A postcard using the slogan and the design of the banner will also be produced to promote membership in the Division.

Professional Development

CLA Conference Program

Maureen Sawa was the CAPL representative on the conference program committee. She reviewed all CLA program submissions for the 2009 conference and consulted with the Executive to ensure their relevance to public libraries. CAPL sponsored a pre-conference workshop on Readers' Advisory, but due to poor registration the workshop was unfortunately cancelled. As a way of having CAPL presence across the country, the CAPL Executive is exploring workshop partnerships with provincial library associations. This year, CAPL sponsored a Readers' Advisory pre-conference workshop at the Atlantic Library Association Conference.

Advocacy/Information Sharing/Partnering

Public Libraries: Building Capacity

Following the launch of the Public Libraries Building Capacity wiki at the conference last year, a committee was established as a standing committee of CAPL to further develop the wiki. The committee held four meetings via teleconference and continues to find ways to make this tool relevant and more accessible to CAPL members. Committee members were: Rachel Sarjeant-Jenkins as chair; Louise Reimer, Edmonton Public Library; Lorraine Salt, Saskatoon Public Library; Deborah Thomas, Burnaby Public Library; and Kelli Wooshue, Halifax Public Library.

Advocacy Now Website

CAPL will be working with CLA to develop a more user-friendly Advocacy Now website in the upcoming year.

Coalition on Community Safety, Health and Well-Being

CAPL renewed its membership in the Coalition on Community Safety, Health and Well-Being, a project initiated by the Canadian Association of Chiefs of Police. The vision of the coalition is that a balanced approach is needed for crime prevention, through emphasizing social development as well as enforcement. Petra Mauerhoff is the CAPL liaison on this initiative.

Member Communications

A Communications Committee was created following the 2008 Annual General Meeting as a standing committee. The Committee brought together under one umbrella several key duties and responsibilities relating to communication within the membership that previously had been split between the various members of the Executive. Responsible for the maintenance of the website with the assistance of the CLA Webmaster, the listserv, blog and Facebook page, the Communication Committee's focus this past year has been on providing information to the membership via a variety of formats. The various formats allow individuals to stay connected to the business of the organization by means of their preferred communication tool. The next step for the Communications Committee is to use the forums at our disposal to provide CAPL members with the means to interact with each other across the country, to discuss pertinent issues, spark conversations about common interests, and share successes as well as lessons learned.

Town Halls

CAPL conducted its second teleconference Town Hall in early March 2009. Rachel Sarjeant-Jenkins and Sheri Bain co-hosted the Town Hall. A successful Town Hall was also held during the Ontario Library Conference in January 2009 and a second one is planned during the Atlantic Library Association Conference in June. Results of the Town Halls were posted on the CAPL website. The Town Halls provide useful feedback to the Executive in planning future direction.

Awards and Bursaries

CAPL/Brodart Award

The award committee met via conference calls and chose Judith Saltman of the University of British Columbia as the winner. The committee decided that the winner of the award will now be announced well ahead of the conference. The mandate was reviewed and instead of giving the award to a librarian in mid-career, the award will now be given to an individual who has made a lasting impact on the local, provincial or national level. Committee members were Susan McLean, Past-President of CAPL as convenor; Nancy Cohen, Past-President of CACL; Don Mills, Mississauga Public Library; and Allan Wilson, Prince George Public Library.

CAPL Conference Bursary and CAPL Northern Exposure to Leadership Bursary

The two bursaries were advertised through the listsery, on the website and on the CAPL Facebook. In addition, various provincial library associations advertised the awards on their listserys. The NELI bursary was awarded to Kelley England of King Township Public Library. The CAPL Conference Bursary was awarded to Stephen R. Warren of Greater Victoria Public Library. Committee members were Petra Mauheroff, CAPL executive as chair and Faye MacDougall, Cape Breton Regional Library.

Nominations

The Committee was successful in identifying members for each of the vacancies on the CAPL Executive. Committee members were Susan McLean, CAPL Past-President as convenor; Joanne Griener, Edmonton Public Library; Diana Guinn, Vancouver Public Library; Barbara Love, Kingston Public Library; and Ingrid Moisil, Gatineau Public Library.

The CAPL Executive moved that Rachel Sarjeant-Jenkins complete Sheri Bain's term as councilor and Lita Barrie continue in her role as CACL President for one more year following the resignation of the Vice-President.

CANADIAN ASSOCIATION OF SPECIAL LIBRARIES AND INFORMATION SERVICES

CASLIS uses our Strategic Plan, adopted in 2003, to direct our activities. We focus our efforts across 4 broad goals:

CASLIS will

- Develop and active, diverse membership
- Develop and provide services that are meaningful to its members
- Continue to develop as a dynamic organization that is responsive to its member's needs
- Ensure its membership is visible within the library, information management and employer communities

Active Diverse Membership

Our structure, with a strong local presence through the Chapters and the Government Section, creates many opportunities for us to interact directly with our members. This focus on our members relies on the hard work of dozens of volunteers across the country. CASLIS promotes the professional benefits of being actively involved, such as the opportunity to learn new skills or take a leadership role. A number our members became CASLIS volunteers for the first time in 2008, serving in a wide range of roles.

CASLIS continues to have a strong student cohort and a wide range of institutions are also included in our membership. Across all categories, CASLIS membership remains relatively steady, with seasonal fluctuations. We value all of our members, and want more of them to value. While we know that CASLIS provides services that are meaningful to our membership and to the broader special library community, we also see that such activities are not always sufficient to create new members.

Develop and provide services that are meaningful to its members

CASLIS, primarily through the Chapters and Section provided an exciting range of programs and member focused initiatives across Canada through out 2008, with over 700 attendees across more than 30 events. Our local presence has always been a CASLIS strength.

CASLIS programs aim for cost recovery; we learned in 2008 that our programs can in fact generate revenue. For example, Ottawa is financial self sustaining thanks to the 2 day seminar in early 2008. Programming revenues in Toronto allows that Chapter to stretch their disbursements from National to create a full year of events. Calgary generates sufficient revenue with their directory to also be self sustaining. Even Special Issues, through the publication of the CASLIS Cookbook, will generate revenues for the Division. Member attendance at programs is always substantial.

Continue to develop as a dynamic organization that is responsive to its member's needs

Bringing Chapter and Section representatives together in September allowed us to learn from and support each other. This planning meeting generates program ideas for the conference, the road show, and for local needs. The result is shared inspiration and motivation, such as Calgary and Edmonton's joint plans for a day long event in early 2009 after seeing the success of Ottawa's event.

While the Calgary-Edmonton event was postponed due to the economic downturn, it is one of many examples of the September meeting creating value for members locally.

The mentoring program has taken some time to get off the ground, but was pursued through 2008 as we determined the best way to post the actual mentoring application forms. We are now using SurveyMonkey to solicit mentors and mentees – please consider it!

The re-launch of Special Issues in 2008 also has provided a venue for members to participate in the community and share knowledge.

Ensure its membership is visible within the library, information management and employer communities 2008 saw CASLIS kick-start a publishing program with the return of Special Issues and the release of three other publications.

After a hiatus of 18 months, Special Issues: Bulletin of the Canadian Association of Special Libraries and Information Services made a comeback in 2008, publishing two issues in April and October. Over 30 members of the Canadian and international library community contributed articles to Special Issues, with numerous written by new professionals.

The CASLIS Chapters and Section continued to maintain strong relationships with student groups and faculty at many library education programs across Canada. Students from both technical and masters programs sat on local executives. Students also benefitted from reduced or no costs at local events.

As CASLIS President, I attended the National Summit on Library Human Resources in early October where I strongly advocated for broader inclusion (beyond the sample of government libraries) of the Canadian special library community in future surveys, preferably in the form of a complete census of all libraries in Canada. We learned of a number of research initiatives in the US and elsewhere that are useful for understanding the situation; it is important to note that many of these materials have strong special library related data sets, showing it can be done!

CASLIS continued to enjoy a presence on Canadian Library Month committee. Canadian Library Month is an important undertaking, promoting libraries of all kinds. We marked our second Canadian Special Libraries Day on the last Thursday of October, which was the 31st in 2008.

CASLIS invested in a professionally designed collapsible upright banner. The graphics we purchased for the banner will also be used on a new brochure to be developed through 2009, and we'll also be using them on our website. I hope you will see the banner some time soon as we try to get it to as many events as possible!

General Comments

CASLIS recognizes its duty to members to use their dues responsibly and in service of member needs. We have sought to keep our governance costs as low as possible, and in 2008 we were under budget in this regard.

CASLIS also recognizes that we would achieve very little without the dedication and efforts of CLA staff, who provide us with their time, expertise and so much more. Our heartfelt thanks go to all of them!

2008 Annual Report

In my address to the BC Library Conference last month, I talked about the 5 Ps: partners, passion, persuasion, purpose and politics. I used the 5 Ps to illustrate how libraries can respond to challenges in our modern world, but the 5 Ps can also be applied to our own situation within CLTA, and our work in the past year. We have striven to work with passion and purpose, to unite and partner with provincial trustee associations, to advocate on the political stage, and to persuade our members and all those invested in libraries to engage with the issues and work towards progress and development.

The Canadian Library Trustees Association is one of the five divisions of the Canadian Library Association. Your executive council for the 2008-2009 year has been: President Jan Harder, the Chair of the Ottawa Public Library Board, Vice-President Betty Thomas, Secretary/Treasurer Elaine Kivisto, the Deputy Chair of Regina Public Library, and Councillor-at-Large Darryl Lucke from the Regina Public Library.

Our goal is to build CLTA into a force for change across the country. As a result, your executive has focused on communications and reaching out to the provincial trustee associations. The results have been outstanding this year and I feel we have bridged many gaps across the country. CLTA has made contact with the Friends of Canadian Libraries, to explore initiatives where CLTA can further the goals of FOCAL. I also made a submission to the federal government regarding fiscal infrastructure programs on behalf of CLTA in January 2009, and urged you all to make the case for public library eligibility for infrastructure funds. As a result, libraries were included in the Culture section of the program. Our voice is growing stronger and is being heard! In these days of economic uncertainty, we need to demonstrate the value of the public library in the community if we are to move from awareness to sustainable funding in the long term.

CLTALK, our quarterly newsletter, has grown this year: its graphics were re-designed in Fall 2008 and content has expanded to include news from contributing members, events of note across the country, and a popular "News Watch" column with links to international library news of interest to trustees. CLTA has also made regular contributions to CLA Digest. In Fall 2008, I co-wrote an article for *Feliciter* about the trustee experience at the 2008 Annual Conference in Vancouver.

I have made many trips across the country in 2008-2009, and I have had the pleasure of meeting many Canadian trustees via the provincial association conferences. At the Ontario Library Association Superconference, CLTA hosted a reception for library trustees, and I gave presentations, including a joint presentation with our city librarian, Barbara Clubb, entitled "Advocacy at Work – Saving Branch Libraries." This session outlined the successful campaign designed by the Friends of the Ottawa Public Library, to save branches from closure in Ottawa. The Friends launched a "Save Our Services" website, an online petition, and an education campaign; as a result, no branches were closed and no hours were cut.

I also presented at the BC Library Conference and the Manitoba Libraries Conference in May 2009. My presentation in Manitoba centred on the bigger picture: fiscal, technological, and demographic challenges, and how libraries can face these challenges head-on with real solutions for growth and enrichment. More on these two trips out west in a forthcoming issue of CLTALK.

I am pleased to announce the winners of the two CLTA awards for 2009. The Stan Heath Achievement in Literacy Award winner is Windsor Public Library. Windsor's long-standing and multifaceted literacy program for adults is in its 29th year! The second award, the Merit Award for Distinguished Service as a Public Library Trustee, goes this year to Rod MacArthur of Sydney, Nova Scotia for his long-standing and active board membership, frequently as chair, on the Cape Breton Regional Library Board as both a councillor and citizen representative. Rod also served two terms as member of the Nova Scotia Regional Libraries Funding Review Committee, and was recognized in 2001 by the Library Boards Association of Nova Scotia (LBANS), when he was awarded its Honorary Membership Recipient for Distinguished Service to Public Libraries in Nova Scotia.

As I write this yearly update, our annual conference is fast approaching. This year we meet in the stunning, diverse and dynamic city of Montréal, and the conference has a full buffet of learning opportunities for hungry trustees to devour. These include our CLTA Annual General Meeting & Reception on Sunday, May 31st, and session entitled "From Awareness to Funding: A Study of Library Support," "The Survey of Challenged Materials in Canadian Libraries: Sharing the Results, Discussing the Findings," The Art of the Woo: Selling Ideas without Selling Out," "Setting the Course and Staying on Target: Implementing a "Just Enough" Model for Strategic Planning and Project Management," and "Questioning Success: Purposeful Thinking, Budgeting Basics for Your Library." To help prepare you for conference season, we focused the last issue of CLTALK on coping with conferences: you can check out http://www.cla.ca/docs/CLTALKMar09.pdf for some last-minute reminders!

I have greatly enjoyed my presidency of CLTA, and I would like to take this opportunity to thank everyone who has worked with me. First of all, thank you to other CLA Executive Council members and to our new Executive Director, for their enthusiasm, commitment and great ideas. Thank you also to members of the CLTA Executive, for all their continued hard work and support this year, and a particular note of heartfelt thanks to the many, many trustees I have met and talked to all across the country, for giving me their precious time and inviting me warmly into their cities, their libraries, and their lives.

CLTA increasingly seeks to be a vehicle for trustees across the country to share with and learn from each other. To support this goal, the final section of this report includes an overview of many of our provincial trustee associations in action this past year.

COLLECTION DEVELOPMENT AND MANAGEMENT

Report on Activities

April 8, 2009

The Collection Development and Management Interest Group (CDMIG) of the Canadian Library Association has the following terms of reference:

- To represent the interests of librarians involved in collections development and management.
- To arrange opportunities for continuing education, both at the national conference, and by means of regional workshops.
- To provide a means of communication between librarians involved in collections development and management.
- To raise the awareness of the library community at large with regards to the issues of concern to librarians involved in collections development and management.

The CDMIG has been involved in a variety of interesting activities in the last year:

Collections Pre-conferences

The collections pre-conference is an almost-annual event (it has been held every year since 2002, save for 2003) and has become the primary project for the CDMIG. The 2008 pre-conference, "Collections 2008: Collections 3.0", was held on Wednesday, May 21 at the Sheraton Wall Centre in Vancouver. Attendance was good, with over 75 people at the event. The 2009 pre-conference is entitled "Collections 2009: Collections in times of innovation and change". It will take place on Friday, May 29 at the Palais des congrès de Montréal. There is an excellent slate of keynote and paper presentations and strong sponsorship support.

CDMIG Award

The CDMIG has an award, the CLA/YBP Award for Outstanding Contribution to Collection Development and Management. This award is designed to "recognize an individual member in good standing of CLA who has made an outstanding local, national or international contribution in the field library collection development or management". YBP Library Services very kindly provides a prize of \$1,000 to be awarded to the winner. The second presentation of the award will be at the collections pre-conference on May 29, 2009. The recipient will be Carol Stephenson, Head, Collections and Acquisitions at Wilfrid Laurier University.

Sponsoring Sessions at the CLA Conference

As in past years, the CDMIG will be a session sponsor at the main CLA conference. This year, there are several sessions that relate to collections work and the CDMIG will be sponsoring two of these:

E-Mail List and Facebook Group

New Convenor/Co-Convenors

I had originally hoped to be stepping down as convenor after the 2008 CLA conference. Unfortunately, for a variety of reasons, I was unable to do so and have carried on as convenor for 2008-2009. I will definitely be leaving the convenor position after this year's CLA conference. There is one person who will be a co-convenor and I am in the process of finding one other co-convenor.

 cooperatively to develop guidelines for a research award.
- EBLIG members continued to be involved in CE presentations and activities on EBL topics and promoted and reported on these activities through the EBLIG wiki and the listserv, including Cara Bradley, Julie McKenna, and Virginia Wilson's presention at the joint Saskatchewan Library Association / Manitoba Library Association conference in Regina, SK, Virginia Wilson's session on EBLIP at the Canadian Association of Law Libraries (CALL) annual

As of January 31, 2008, we had a total of 41 members, which is an increase of 17% over the previous membership report on July 31, 2008.

Events

- 1. The CLA Montreal Chapter continued its monthly series of informal, bilingual meetings for the Montreal library community called Salon des Bibliothécaires. These get-togethers are centered on a theme and offer an opportunity for librarians and anyone connected to the local community to come together to share their experience and point-of-view with others. Most months, the gatherings have been attended by approximately 10-14 people, and have taken place in various cafés where participants are not charged admission, and are free to purchase supper or refreshments. We have one more Salon to be held April 30th, which will bring our total to 5 of these events in 2008-2009.
- 2. The Chapter participated in the national Librarians Run for the Cure team on September 30th, 2008. Local team members ran or walked the Run for the Cure route in Montreal, and Jocelyne Andrews represented the Chapter as our local team captain. Lina Gordaneer, Laura May and Leticia Cuenca also attended.
- 3. On November 21rst, 2008, the Chapter joined with CASLIS Ottawa to offer a Project Management workshop given by Colin Lindsay. Around 50 people attended. The event was very popular and much appreciated.
- 4. This year's reception for the CLA President, Ken Roberts, took place on January 27th, 2009. The Chapter continued its tradition of supporting the McGill Student Chapter in this event by helping to defray the cost of refreshments.

TECHNICAL SERVICES

Annual Report April 13, 2009

In March of 2009, it was confirmed that the proposed merger of TSIG and SIG was approved. An email had been sent to both memberships in order to confirm that this was a change everyone understood and approved of; the response was overwhelmingly popular, and it was submitted to CLA Executive Council for final approval. We expect this to be a time saver for CLA administration, and reduces the need to drum up interest for two executives. The convenor-elect for TSIG, Marcia Salmon, is aware of the change and has no problem with taking this on. Both the CLA website, and the TSIG wiki have been updated to reflect the merger.

Pre-conference and conference planning has been active this year. TSIG has two sponsored sessions approved for the conference in Montreal. They are as follows:

- 1. Implementing Primo at the Tri-University Group of Libraries presented by Alison Hitchens
- 2. SACO (The Subject Authority Component of the PCC): An Introduction and Discussion of McGill's Experience presented by Karen Jensen

We have also coordinated an evening social event during which topical discussion groups will be organized. This provides an excellent opportunity for like minded individuals to discuss issues that they are facing in their libraries in a relaxed atmosphere with refreshments. We held this same event last year and it was met with great success. We had a good turnout, enough to fill three round tables, and with help from the organizer, Doug Kariel, there was much engaged discussion at each table with suggested topics and talking points. Everyone enjoyed the snacks and drinks provided; it was a good mix of socializing and a chance to discuss "hot topics" in technical services. We will hold it again this year, and again, assess if we should make it a standing event (budget permitting).

Most activity this year, however, has been focussed on organizing TSIG's second pre-conference. This time, we will be focussing solely on RDA. Myself, Pat Riva, Chris Oliver, Trina Grover and Marcia Salmon have been working together to secure outstanding speakers who are able to speak authoritatively about the development of the new cataloguing standard. We have had an overwhelming response so far; at press time, there were well over 100 registrations. We decided to use an off-site venue as we did expect a large turnout. Pat Riva was able to secure the Bibliotheque Nationale auditorium for the day, at no cost. I was able to secure some sponsorship from Coutts and Blackwell's to help offset the refreshment costs at break time. Due to the size of the event, we will be supplying a list of nearby restaurants for lunch.

We wanted to keep registration affordable, however, we also decided that any profit we made would be beneficial as we anticipate upcoming expenses for supporting the delivery and development of RDA training. We will also be looking to CLA for support for any such approved endeavours. It has been agreed that this is a good fit for TSIG activity, and we have the membership and expertise to be leaders in this area. Furthermore, we also decided to explore possibilities for webcasting the day's events. Through a great deal of research and consultation (not to mention the purchase of equipment by none other than Ryerson Library), we will be offering a free webcast for the masses. It will be hosted on an open source website called ustream.tv. We anticipate that this will be a popular option for many who cannot afford to travel to Montreal.

Contrary to last year's experience, we received an overwhelming reaction to our call for nominations for the CLA/3M award for achievement in technical services. A new committee was formed (again, with a very positive response), comprised of myself as Chair, and Marcia Salmon (convenor-elect and standing member), and the newest member, Thomas Brenndorfer. Thomas will stand for two years, Marcia will act as Chair and we already have a new member ready to step in to replace Marcia as a standing member.

As for the award itself, we received five very impressive nominations. Two were from public libraries and three from academic libraries. It was a unanimous decision of the group to select the "Open Sourcing the Serials Workflow" submission from the Robertson Library team at the University of Prince Edward Island. Mark Leggott, the chief librarian, will accept the award during the pre-conference event.

As for our upcoming meetings, we have decided to forgo the IG breakfast meeting this year. We have been unsatisfied with this venue for our AGM for quite some time. It was too late to try to reserve a conference room to hold it during an alternate time slot, so we have made alternative off-site arrangements. In the future, we will be recommending that alternatives are explored for these breakfast meetings as they almost always run into conference session time slots, and the rooms in which they are held are often too noisy to actually conduct a proper AGM. Especially since this year a new convenor, Marcia Salmon will be taking over, we decided to opt for something quieter. We will therefore, be holding our AGM on Saturday May 30th, at 11am at La Popessa located at 115 St. Antoine Ouest. Lunch will follow.

COPYRIGHT WORKING GROUP

Submission to the Annual Report

The Copyright Working Group had two main tasks over the last year.

At our annual meeting in Vancouver, one of the issues we discussed was *demand letters* and how libraries should respond to them. A subcommittee comprised of Margaret Ann Wilkinson and Mary Anne Epp came up with a statement that is now posted to the CLA website:

INTERNATIONAL TRADE TREATIES WORKING GROUP

Annual Report. May 2009 Convenor: Kirsti Nilsen.

The International Trade Treaties Working Group (ITTWG) is a division of the Standing Committee on Intellectual Property and Public Access, along with the Copyright Issues Working Group and the Information Policy Working Group. These groups cooperate in their efforts to ensure that the broader CLA membership is aware of issues related to these topics, and to provide input to the CLA executive.

At the CLA 2008 annual meeting in Vancouver, ITTWG brought forward a resolution on the Trade, Investment, and Labour Mobility Agreement (TILMA) and the Agreement on Internal Trade (AIT), which was approved at the AGM on May 24, 2008.

At the request of the executive, the convenor prepared a "Backgrounder and Annotated Bibliography on AIT and on TILMA and AIT" which was available for the January 2009 board meeting and which is now available on the CLA Web site at http://www.cla.ca/AM/CLA-AITandTILMAbackgrounderJan2009byNilsen.doc

On behalf of the Intellectual Property and Public Access Committee, Kirsti Nilsen wrote an article entitled "Book and Magazine Publishing Policies in Canada" which was published in. Feliciter 54 (3): 109-112.

The Committee also proposed a Feliciter theme issue on information policy which is being co-edited by Kirsti Nilsen and Heather Morrison, co-convenor of the Information Policy Working Group. A call for papers has been issued. This theme issue is tentatively scheduled to appear in July/August 2010.

ITTWG has scheduled no conference presentation on trade issues for the 2009 CLA conference. However, the convenor participated in planning discussions, and the group will participate in the Intellectual Property and Public Access Committee meetings.

Kirsti Nilsen's term as convenor ends this year.

STANDING COMMITTEE ON RESEARCH AND DEVELOPMENT

Annual Report to the CLA Executive Council for 2009-10

Committee activities:

Research & Development Grant:

- Promoted the Grant primarily by notice in Feliciter and CLA website. Also posted reminder messages on the CLA listserv and various library listservs including CARL and others.
- Reviewed and scored applications for the CLA Research and Development Grant. We received 3 applications this year, down from 10 last year. This year all applications were received via email rather than hard copy. One of the co-convenors blinded all applications before distributing them to committee members to limit bias. A committee member excused herself from offering comments on one application as she was familiar with the candidate. The grant was awarded to Jean McKendry for her project: A Qualitative Analysis of Public Library Architecture and the Use of Public Space in Libraries by Persons Experiencing Homelessness.
- The committee used the scoring sheet developed by the committee in previous years. As a result of our grant deliberations this year the committee will review the scoring tool and evaluation criteria again for next year.
- Although no applications in French were received this year CLA has agreed to accept applications in French and then pay to have the application translated into English for review.

Collaborative Activities

- The R&D Committee has been in regular contact with LIRG the Library and Information Research Group of the Chartered Institute of Library and Information Professionals in the UK, including three face to face meetings in the UK, one in December 2007 with several members of LIRG including the Chair, one in November 2008 with the Chair and the LIRG Officer responsible for developing their research register and another in April 2009 with the Editorial Board for LIR the journal of LIR. The purpose of these meetings was first to determine if there was interest in collaboration in a) developing a register of research findings in the LIS fields b) sharing research training tools, encouraging publication in LIRG for Canadian researchers and d) sharing research strategies including lists of research priorities and other documents related to research awards, etc.
- There was initial interest from LIRG in collaborating with CLA R&D Committee at the first meeting and subsequent
 meetings were set up to explore this further. The CARL Library Education Working Group which leads on CARL's
 R&D initiatives and strategy was also part of this meeting. Since that meeting, there was been an exchange of strategies
 and documents e.g. criteria for awarding research grants.
- At the November 2008 meeting, the main focus for discussion was focused on developing a shared research register of LIS research in the UK and Canada. LIRG was in the process of developing their register and demonstrated their Beta version. However, this turned out to be a register of researchers in the UK and not published research findings. LIRG said that there was an Italian open access website which does take LIS research from around the world as long as authors agree to open access. LIRG was interested in having Canadian researchers listed in their register and asked for a Canadian "editor" to handle contributions to the register when it is ready.
- The third meeting involved the LIR Editorial Board. One of the CLA Co-Chairs of the R&D Committee is on the Editorial Board. There was great enthusiasm for Canadian contributions to the journal.
- The R&D Committee discussed these meetings very briefly at its last meeting. The view was that it was a shame the
 LIRG register was not of research findings and there was consensus that Canada needed its own research register
 which included sabbatical and in-house research findings. Members agreed to discuss with CARL whether work on a
 Canadian register could be shared (NOTE a CARL member had volunteered to do a register of Canadian academic
 LIS research but subsequently withdrew the offer).
- There was some interest in encouraging Canadian LIS researchers to contribute to the Italian site but it was recognized
 that not all researchers would publish in an open access international repository. Similarly there is interest in
 encouraging Canadian researchers to contribute to LIR and other international research journals but it was also felt
 that we should be encouraging publication in Canadian and particularly open access journals e.g EBLIP.
- Liaison with LIRG and with the CARL LEWG and other groups focused on LIS research will continue and proposals
 for a Canadian LIS research register may be brought to the CLA Board in due course.

The CLA R&D Committee would welcome an opportunity to speak with the CLA Executive about the importance of research in the CLA Strategic Plan.

CLA WORKING GROUP ON THE INITIATIVE FOR EQUITABLE LIBRARY ACCESS (IELA)

Report on activities - 2008-09

CLA's Working Group on IELA began early in 2008 and has met one time in person at the 2008 CLA Annual Conference and seven times via teleconference since then. We were pleased that staff members from Library and Archives Canada's IELA Project have been able to participate in the meetings. Terms of reference were developed to guide the Group's work.

The working group has supported the Library and Archives Canada (LAC) IELA in a variety of ways. The working group consists of eleven CLA members and two members representing visually impaired and learning disabled library users. IELA is building the case for government funding of equitable access to public library service for people with print disabilities who need alternative format materials. The working group has provided input to LAC on a variety of topics including: a survey of public libraries to assess technology readiness and gaps; marketing and communications strategies for services; the electronic clearing house and library service standards and training guidelines. LAC is tasked with making recommendations to the federal government on funding strategies. In conjunction with this the Working Group is pressing for a broader discussion of the roles and responsibilities of stakeholders in this initiative: public libraries, CNIB Library, BAnQ, and LAC. A sub-committee has been formed to address this and report in early Fall 2009.
