CLA Challenges Survey 2015

Did your library deal with a book or policy challenge in 2014?

This is the 9th annual survey of challenges to library materials and policies that is being conducted by the CLA Intellectual Freedom Advisory Committee.

Your responses will help inform the Committee's policy and advocacy work on behalf of the CLA membership. Results are shared widely, for example, with the International Federation of Library Associations and Institutions, the Book and Periodical Council [of Canada], and the Office of Intellectual Freedom of the American Library Association. An anonymized version of the database is available without charge to anyone requesting it.

The purpose of the survey is to gather data about the nature and outcomes of challenges to library materials and policies (e.g., collection management, access to Internet and facilities) initiated in publicly funded, Canadian libraries (e.g., public, school, academic, and government) between JANUARY 1 and DECEMBER 31, 2014.

One form should be submitted for each challenge to an item or a policy.

The Canadian Library Association in partnership with the Department of Canadian Heritage, Young Canada Works program is delighted to announce the completion of our selection committee process. Our selection committee met for two days, March 26th and March 27th to review all 154 applications, from 130 libraries. Organizations are ranked on financial need, the clarity of their application, the heritage goals that their summer student position fulfills, as well as, the Department of Canadian Heritage's mandate of offering students, gainful employment in the heritage (library) sector.

This year, we are pleased to be able to fund 100 summer library positions and 4 internships, from coast, to coast, to coast. Decisions regarding next steps (approval or

In a continuing tradition of commitment to excellence in library education and advancement of continuing research in the field of library and information science, the Canadian Library Association/Association canadienne des bibliothèques offers two scholarships : The H.W. 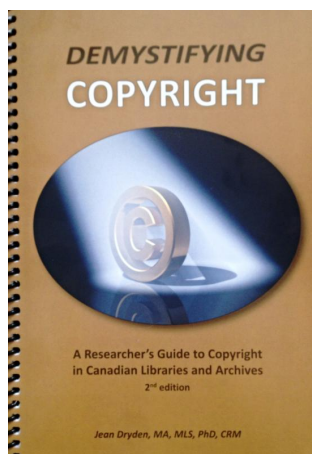
### **What are you passionate about?**

Much has changed since the first edition of Demystifying Copyright was published in 2001. In the years that followed, the federal government embarked on a process of copyright reform to fulfill Canada's obligations under international copyright treaties and to address how copyright operates in the digital environment. Some minor amendments to the Copyright Act we made in 2004, and the Act was significantly amended in 2012, when Copyright Modernization Act was passed. The amendments discussed in this edition came into force 7 November 2012.

This second edition reflects the key changes to Canada's copyright law since 2004 that

are of particular relevance to people who conduct research in the nation's libraries and archives, and to the librarians and archivists who serve them.

### **IFLA Publishes "Guidelines for Library Services to Persons with Dyslexia - Revised and Extended"**

The IFLA Guidelines for Library Services to Persons with Dyslexia - Revised and extended - aims to offer guidance to IFLA professional units and all its members worldwide on developing and implementing library services for persons with dyslexia. These guidelines are both a revision and an expansion of the previous Guidelines published by IFLA in 2001 as Professional Report No. 70.

The Guidelines have been developed by an international working group working under the joint responsibility of both the Library Services to People with Special Needs Section (LSN) and the Libraries Serving Persons with Print Disabilities Section (LPD). These new guidelines aim to assist libraries in providing services to persons with dyslexia. They can also be applied to other groups of users with reading difficulties. [Read More](#)
