

## Canadian Rublic Libraries for Fair Ebook Pricing

ebook prices charged by multinational publishers at <a href="www.fairpricingforlibraries.org">www.fairpricingforlibraries.org</a>. Despite booming borrowing rates and high demand for ebooks, public libraries face challenges in ensuring universal access to this content.

Some multinational publishers charge libraries as much as three to five times more for ebooks than the consumer price, while others place caps and time limits on use. This means there are fewer titles and fewer copies for readers to discover.

Canadian Public Libraries for Fair Ebook Pricing will continue to communicate its position to several government and publishing stakeholders, and to work collaboratively with other large public library systems across North America.

The coalition will hold continued conversations with multinational publishers as part of an effort to establish fair and reasonable prices and obtain more ebooks.

#### Community-Led Work in Practice: Experiences from Canadian Libraries

One of the CLA Community-Led Library Service Network's goals for 2014-2015 was to create a series of papers exploring aspects of community-led work, providing an opportunity to share information about the work being done in Canadian libraries and offering useful information and ideas to others in an accessible and readable format.

Network members have so far contributed eight papers on a variety of topics, which have been posted on the Community-Led Library Service Network website.

Laura Young wrote about Edmonton Public Libraries' epl2go, a mobile service providing communities with library services when access to a traditional library branch is limited. In Let the Community lead, Andrea Cecchetto and Leah Rucchetto shared Markham Public Library's experience using a community-led approach in developing their strategic plan. Rejuvenating library service in a rural community through community engagement was the focus of a post by Amanda Fullerton and Sara Gillis of Halifax Public Libraries.

John Pateman of Thunder Bay Public Library contributed a series of posts on developing a community led strategy, staff and service structures, systems and culture.


Learn about one of our fabulous members

## **Community Highlights**

#### Transition timescales for RDA Governance

In June 2015, The Committee of Principals shared an initial statement with stakeholders which outlined the direction for the future development of the Governing structures for the development of RDA.

This statement committed to sharing a detailed transition plan with stakeholders prior to IFLA's World Library and Information Congress in 2015.

Having reviewed the agreed changes, the Committee has agreed a 4-5 year programme of activity to enable the current structure to move, over time, towards the new governing structure.

#### **Risk Register for Documentary Heritage**

IFLA has created a <u>Risk Register for documentary heritage</u> in order to raise awareness for the preservation, conservation, and safeguarding of documentary heritage (in any format) world-wide. They aim to gather data on documentary heritage collections in order to be able to respond adequately if confronted with natural or man-made disasters.

The Risk Register enables IFLA to provide contact and geo-spatial information to <u>UNESCO</u> and the organisational partners of the <u>International Committee of the Blue Shield</u> acting in case of disaster. This increases the survival of unique documentary heritage and its safeguarding to help rebuild communities in the post-disaster recovery period and beyond. <u>Read More</u>

#### The NMC Horizon Report - 2015 Library Edition

The report examines key trends, significant challenges, and important developments in technology for their impact on academic and research libraries across the globe.

#### Excerpt:

What is on the five-year horizon for academic and research libraries worldwide? Which trends and technologies will drive change? What are the challenges that we consider as solvable or difficult to overcome, and how can we strategize effective solutions? These questions and similar inquiries regarding technology adoption and transforming teaching and learning steered the collaborative research and discussions of a body of 53 experts to produce the NMC Horizon Report: 2015 Library Edition, in partnership with the University of Applied Sciences (HTW) Chur, Technische Informationsbibliothek (TIB) Hannover, and ETH-Bibliothek Zurich. The NMC Horizon Report series charts the five-year horizon for the impact of emerging technologies in learning sectors across the globe. With more than 13 years of research and publications, it can be regarded as the world's longest-running exploration of emerging technology trends and uptake in education. #### IFLA Statement on Privacy in the Library Environment

At its 14 August 2015 meeting in Cape Town, South Africa, the IFLA Governing Board endorsed an IFLA Statement on Privacy in the Library Environment. The FAIFE Committee oversaw preparation of the Statement and benefitted from consultation with IFLA units and various Internet civil liberties advocacy organizations.

This new Statement on Privacy in the Library Environment is intended to give guidance to libraries and information services in an environment that includes mass surveillance by

governments and routine user data collection by commercial interests that provide content or services through the Internet. Risks to library users' privacy might arise through their use of search or social media applications on the Web or their use of library platforms and content that collect data on end users.

The statement describes current challenges to the protection of user privacy for libraries and information services, outlines relevant international statements of privacy as a right and identifies related IFLA policies. Finally, the Statement on Privacy in the Library Environment offers recommendations to libraries and information services around both advocacy for privacy protection and practical measures to protect user privacy in libraries. It recognizes that libraries and information services have little ability to affect some kinds of data collection about their users, and encourages appropriately adjusting local library data collection practices, considering privacy concerns in procuring platforms and services, informing and educating users of risks and best practices, and participating in community efforts to promote the protection of privacy.

The concepts, processes and practice comprising digital curation are, in 2015, prominent in many journals, but clarification on best practice is still desirable. Libraries and other collection institutions are aware of the need to manage their digital resources: from creation, indexing, storage, preservation and dissemination of data, to understanding tools for analysis and the subsequent addition of value, the establishment of workflow policies, promotional outreach and fundraising. The phrase digital curation is perhaps primarily understood within the cultural context, but it also encompasses management of research data.
