

# Results of the Special General Meeting - January 27, 2016

The Canadian Library Association (CLA) has taken the first formal step to establish a new unified national library advocacy organization.

CLA has been the national voice of the Canadian library community since 1946 and has profoundly changed the awareness of libraries and advanced many issues of critical importance to libraries and to Canadians. The work of CLA has created a permanent legacy that positively impacts Canadian libraries and all Canadians. At the Special General Meeting of the Canadian Library Association held Wednesday January 27, 2016 in Toronto, the membership voted to dissolve the Association.

The dissolution of CLA follows an extensive process during which CLA worked with a large number of library associations across Canada to develop a proposal to advance the interests of libraries. The proposed Canadian Federation of Library Associations unifies the diverse library communities across Canada. CLA's membership took this decision with a view to the future. Changing times and a proliferation of other library associations has seen a decline in CLA membership resulting in challenges in sustaining an effective organization. It was clearly time to reconsider the viability of the organization. The Executive Committee unanimously supported the motion to dissolve CLA in order to enable the creation of a new national federation. Over the next few months CLA will undertake the normal requirements to wind down an organization and pave the way for the Federation.

While the demise of CLA is regrettable, the rise of the Federation as a new and more effective voice for Canada's libraries is a reason to celebrate. Read More

# 2016 CLA Forum News



As you may be aware on January 27th, 2016 the Canadian Library Association (CLA) membership voted to dissolve the CLA predicated on a proposal for the creation of a new national association that will focus advocacy, research and policy. That being said, we wish to assure the community that the CLA Forum will continue as planned on June 1-3, 2016 in Ottawa.

Our program planning to date includes a new format that will reflect the proposed direction for the new Canadian Federation of Library Associations and that will work within the confines of a new space which means our traditional program and layout of the trade show floor will change.

Why should you attend? We are developing a strong program that will focus on 10 topics that are of great significance within the library community and in the end will form an advisory document of recommendations that will be presented to the Canadian Federation of Library Associations.

The forum will kick-off on Wednesday June 1st with an opening keynote at 1PM, optional network/committee meetings as well as the Innovative Technology session will run during the morning.

The forum will conclude Friday June 3rd after lunch.

# **Young Canada Works**

#### **Summer Jobs**

We are delighted to report that 105 libraries have submitted applications for 143 positions for the Summer Jobs Program. In addition to applications already submitted, there are 14 libraries who have begun, but not completed applications. The YCW Coordinator will follow up with each library and the hope is that they will complete applications for 14 additional positions (not included in the total mentioned above).

Under the terms of the Contribution Agreement with Heritage Canada, CLA can fund up to 100 positions and if every library completes their application, this year, we will have a total of 119 libraries applying for 157 positions.

### **Internships**

9 libraries have applied for 10 positions. There are an additional 3 applications uncompleted in the system. If these additional applications are completed, the total number of internship applications will be 12 libraries applying for 14 positions. Under the terms of the Contribution Agreement with Heritage Canada, CLA can fund to fund up to 4 internships.

#### **Selection Committee**

This Committee will meet in late February to select applications to be funded. CLA would like to express its gratitude to the members who have generously offered their time and talent to assist in selecting libraries to be funded by these very worthy programs.

# How Does The New Policy Influence Us In Our Daily Learning Commons Adventures?

This revised series supports the Alberta Learning Commons Policy with ideas, tools, and participant activities in a series of 6 webinars framed on using A Guide to Support Implementation, Essential Conditions. - \* establishing dialogue groups for learning commons teams to meet with other teams nearby and share timely topics
- \* conference/in-service information
- \* new professional resources.




