

Canadian Library Association Announces 2015 - 2016 Executive Council and Interim Appointments to Councillor-at-Large Role

It is with great pleasure that the CLA Executive Council announces that the following CLA members have been acclaimed to the 2015 - 2016 Executive Council:

- Rosemary Bonanno as Vice President/President-Elect (June 2015 June 2016) followed by President (June 2016 - June 2017) and Past-President (June 2017 -June 2018)
- Virginia Clevette as Councillor-at-Large (June 2015 June 2017).

In addition, Executive Council has appointed two CLA members to the role of Councillorat-Large on interim basis. Peggy D'Orsay (Whitehorse, Yukon) and Jim Bennett (Ottawa, Ontario) will join Executive Council immediately for a term that ends in June 2015.

In June 2014 CLA Executive Council presented a list of nominees for election by the membership. Since that time several of those individuals withdrew their names for personal reasons. As a result, there will be no election for the 2015 - 2016 term and the candidates for Vice-President and Councillor-at-Large have been acclaimed.

We would like to thank all those who expressed an interest in serving on the CLA Executive Council. It is a testament to the passion and dedication that the library and information community have for the issues of importance to them and for its national association.

Executive Council welcomes these four CLA members. We look forward to having Ms. D'Orsay and Mr. Bennett join them immediately as members of EC and for Ms. Bonanno and Ms. Clevette to join them in June 2015.

Executive Council Meeting Highlights

Executive Council met January 31 in Toronto following the 2015 OLA Super Conference. The meeting was both productive and efficient. Highlights include:

There was considerable interest from the membership in the IFLA Governance

Board and Section nominations. EC has approved names to go forward as nominations from CLA. Once we have finalized communication with those who expressed an interest we will share the names of CLA's nominees for the 2015 - 2017 IFLA Elections.

- A decision was made to use the remaining funds from the now defunct Bibliomondialis towards an update of the 8Rs study. In keeping with the Bibliomondialis mandate there will be a requirement to publish or present the findings internationally.
- CLA has begun the process of preparing a response to the Royal Society of Canada Report on the future of Libraries in Canada. A working group has been struck consisting of members of the working group who drafted CLA's original response and they have met to begin their review.
- The work of the E-Books Task Force is well underway; they anticipate having something to present to EC prior to the June 2015 conference.
- Planning for the 2015 conference is also well underway. The Program Committee
 meets the weekend of Feb 7 and 8 to finalize the program. We aim to launch
 registration towards the end of February. The Planning Committee has lots in store
 for you so we hope to see you in Ottawa June 3 5.
- Discussion took place regarding the future of Canadian Library Month. Further
 discussion will take place with the CLM partners however it is anticipated that CLA
 will focus and enhance its efforts to promote libraries and library issues in the future
 on an ongoing basis as opposed to one month out of the year.

The non-confidential materials for this meeting were posted in advance in the <u>myCLA</u> section of the website. Minutes will be posted once approved.

Canadian Library Association: A Proposed New Vision for our National Association

On January 31, 2015, CLA Executive Committee met with upwards of 40 representatives from library associations across Canada to discuss the recent CLA Executive published concept paper, Canadian Library Association: <u>A Proposed New Vision for our National Association</u>.

As noted in the paper, which was shared with CLA members on January 2, 2015, the first step after sharing the paper was to discuss the proposed approach with the major library associations in the country to determine whether there was interest. This was the purpose of the January 31 meeting.

CLA Executive would like to express our sincere appreciation to the association representatives who attended the meeting and actively participated in a constructive and productive conversation about CLA and the ideas expressed in the paper. Two key themes that arose during the discussion were:

- An agile and focused national voice for libraries and information rights in Canada is critical;
- There was a willingness to continue to further explore the federated model for CLA,

recognizing that the direct membership model is no longer sustainable for our national association.

Over the next few months, CLA Executive Council will convene a working group of library association representatives to further refine the proposal, articulating options for funding, membership options, and governance structures. These ideas will then be shared back with the library association stakeholder group - we are hoping for a meeting during the CLA 2015 conference.



CLA Challenges Survey for 2014 Calendar Year

This is the 9th annual survey of challenges to library materials and policies that is being conducted by the CLA Intellectual Freedom Advisory Committee.

Your responses will help inform the Committee's policy and advocacy work on behalf of the CLA membership. Results are shared widely, for example, with the International Federation of Library Associations and Institutions, the Book and Periodical Council [of Canada], and the Office of Intellectual Freedom of the American Library Association. An anonymized version of

the database is available without charge to anyone requesting it.

The purpose of the survey is to gather data about the nature and outcomes of challenges to library materials and policies (e.g., collection management, access to Internet and facilities) initiated in publicly funded, Canadian libraries (e.g., public, school, academic, and government) between JANUARY 1 and DECEMBER 31, 2014.

One form should be submitted for each challenge to an item or a policy.



Much has changed since the first edition of Demystifying Copyright was published in 2001. In the years that followed, the federal government embarked on a process of copyright

reform to fulfill Canada's obligations under international copyright treaties and to address how copyright operates in the digital environment. Some minor amendments to the Copyright Act we made in 2004, and the Act was significantly amended in 2012, when Copyright Modernization Act was passed. The amendments discussed in this edition came into force 7 November 2012.

This second edition reflects the key changes to Canada's copyright law since 2004 that are of particular relevance to people who conduct research in the nation's libraries and archives, and to the librarians and archivists who serve them.
