Of the members of the Canadian Library Association to consider the dissolution of the Corporation January 27, 2016 11 a.m. to 1:00 pm Eastern time Metro Toronto Convention Centre Room 204 255 Front Street West Toronto, Ontario.

The Special Meeting of CLA members will present an important question to the CLA membership and it is important that all CLA members who have the right to vote participate in the vote.

Electronic viewing of the meeting will be available for people who cannot attend in person and CLA will provide a mechanism for people who are not present in person to ask questions or make comments. HOWEVER, BECAUSE OF THE COMPLEXITY OF CLA'S MEMBERSHIP STRUCTURE, MEMBERS ATTENDING VIA WEBCAST WILL NOT BE ABLE TO VOTE REMOTELY AND SHOULD CONSIDER ASSIGNING A REPRESENTATIVE (FOR INSTITUTIONAL, ASSOCIATE, OR CORPORATE MEMBERS) OR PROXY HOLDER (FOR PERSONAL AND HONORARY MEMBERS) WHO WILL BE PRESENT AT THE SPECIAL MEETING TO CARRY THEIR VOTE. PROXY HOLDERS MUST BE MEMBERS OF CLA.

CLA releases Canadian Copyright in Schools and School Libraries: A Primer

On January 21, 2016, the Canadian Library Association released its final publication

Canadian Copyright in Schools and School Libraries: A Primer. The guidebook, written by John Tooth, was written to assist school library staff and classroom teachers in their understanding of copyright law and Supreme Court of Canada decisions on fair dealing. This very practical handbook includes a description of new beneficial copyright clauses, recent advantageous fair dealing interpretations and an examination of specific copyright issues that arise in schools. Respectful of authors' and publishers' rights, the book also discusses the limitations on these new users' rights and interpretations.

Summer Jobs

We are delighted to report that 105 libraries have submitted applications for 143 positions for the Summer Jobs Program. In addition to applications already submitted, there are 14 libraries who have begun, but not completed applications. The YCW Coordinator will follow up with each library and the hope is that they will complete applications for 14 additional positions (not included in the total mentioned above).

Under the terms of the Contribution Agreement with Heritage Canada, CLA can fund up to 100 positions and if every library completes their application, this year, we will have a total of 119 libraries applying for 157 positions.

Internships

9 libraries have applied for 10 positions. There are an additional 3 applications uncompleted in the system. If these additional applications are completed, the total number of internship applications will be 12 libraries applying for 14 positions. Under the terms of the Contribution Agreement with Heritage Canada, CLA can fund to fund up to 4 internships.

Selection Committee

This Committee will meet in late February to select applications to be funded. CLA would like to express its gratitude to the members who have generously offered their time and talent to assist in selecting libraries to be funded by these very worthy programs.

A Message from Library and Archives Canada

At a meeting of the Ottawa Public Library Board on January 12, 2016, it was announced that the Ottawa Public Library (OPL) and Library and Archives Canada (LAC) will explore a potential and innovative partnership opportunity with respect to the new Central Library project and the development of a landmark facility in the nation's capital.

While acknowledging the differences and unique qualities respective to our two organizations, we both provide public services that are a source of tremendous synergy. Our goal is to explore the possibility of partnering together in a shared-use facility to offer value-added services to our clients.

Over the coming months, we will consider the terms of an innovative partnership opportunity that would allow LAC to move some activities and services from 395 Wellington Street to a joint facility with the OPL at a site in close proximity to our current location in central Ottawa.

I am very enthusiastic about this opportunity to significantly expand our client base. I also want to assure you that there are no plans to reduce staff as part of this initiative. This is an exciting time for LAC and the OPL, and for the National Capital Region, as we explore opportunities on this incredible city-building initiative on the eve of Canada's 150th birthday.
