## **News From CLA**

#### **CLA Response to Federal Budget 2015**

On April 21, 2015 Minister Joe Oliver released his federal Budget for 2015 entitled Strong Leadership: A Balanced - Budget, Low - Tax Plan for Jobs, Growth and Security. Included in the budget were two measures that directly affect the library community. CLA is very pleased with the proposed amendments to the Copyright Act to implement and accede to the Marrakesh Treaty to Facilitate Access to Published Works for Persons Who Are Blind, Visually Impaired or Otherwise Print Disabled. The CLA is concerned however with the proposed amendments to the Copyright Act so that the term of protection of performances and sound recordings is extended from 50 years to 70 years following the date of the release of the sound recordings. <u>Read More</u>

## **Executive Council Update - May 1, 2015**

Executive Council has met two times since our last update; April 10 and May 1. Highlights of these two meetings are listed below.

- Updates and discussion have taken place on the revitalization of CLA. Update to this process can be found on the blog created by the Stakeholder Working Group as a means of keeping the community informed. <u>http://futurecla.wordpress.com</u>
- The Intellectual Freedom Advisory Committee is working on an update of CLA's Statement on Intellectual Freedom. Executive Council reviewed a first draft of this update which will be ready for membership review in the near future.
- The Code of Conduct Task Force continues its work. The goal is to have an approved code of conduct for CLA activities and events for implementation at CLA 2015. A member review of this document will be undertaken in the coming weeks so please keep an eye open for that communication.
- Executive Council keeps a close watch on the progress of the planning of the CLA National Conference and Trade Show and is now receiving monthly reports on the status of planning, registration, sponsorship and exhibits. Things are progressing well and EC is looking forward to a conference filled with excellent content and lots of networking opportunities. If you have not already registered please do so via the <u>CLA 2015 conference website</u>.
- Executive Council also keeps a close watch over CLA finances and undertakes regular reviews of the financial statements. Executive Council has approved CLA's budget for 2015 and have drafted a Preliminary budget for 2016 so that it able to monitor and anticipate CLA finances throughout the organizational revitalization. CLA Treasurer Michael Ridley will be providing a report on finances at the AGM in Ottawa, Ontario on June 4, 2015 (3:00 4:30 pm Eastern time).
- Executive Council approved the recommendation of the Research and Grants Jury to award CLA's annual research grant of \$1000 to Rumi Graham and Christina

Winter for their research project titled "Copyright Practices and Approaches in Canadian Universities: A National Survey". Congratulations to Rumi and Christina!

- The e-Book Task Force has been hard at work developing a position and advocacy plan related to e-Books. Executive Council reviewed and approved the recommendations brought forward by the Task Force in April. These materials will be available on the CLA website on the <u>e-Book Task Force page</u> in the coming weeks for your information. CLA has also joined <u>ReadersFirst</u> and has endorsed the OPL/TPL <u>Fair Pricing for Libraries</u> campaign.
- Executive Council, with assistance from IMPACT, is developing a 2015 federal election campaign. We will be seeking input from members on which issues are of most importance to you. Please look for this survey link the first week of May 2015.

Executive Council 's next meeting is on June 2 and 3 in conjunction with the 2015 CLA National Conference and Trade Show in Ottawa, Ontario. Materials will be uploaded to myCLA on the CLA website in advance of the meeting should you wish to access these. Members are welcome to observe these meetings, if you intend to be present in June in Ottawa we ask that you please let us know in advance by emailing Agnieszka at info@cla.ca so that we can be sure to have enough chairs for everyone.

**Community-Led Work in Practice: Experiences from Canadian Libraries** 

One of the CLA Community-Led Library Service Network's goals for 2014-2015 was to create a series of papers exploring aspects of community-led work, providing an opportunity to share information about the work being done in Canadian libraries and offering useful information and ideas to others in an accessible and readable format.

#### Cataloging Music Resources in RDA eCourse (4 week course)

Are you struggling with cataloging music in your library? The latest release of RDA: Resource Description and Access, on February 7, 2015, now includes the addition of Music Library Association for Best Practices for Music Cataloging (MLA BP). ALA Editions presents a new eCourse, Cataloging Music Resources in RDA facilitated by Sonia Archer-Capuzzo, which

explores the unique challenges of cataloging music resources and focuses on how RDA Toolkit meets these challenges. More and more libraries are making the switch to RDA cataloging, and training like this becomes more important to the process.

\* Identify the differences between Works, Expressions, Manifestations, and Items and how those differences affect cataloging of music materials. (Bloom's Taxonomy: Analysis)

\* Interpret the instructions in RDA Toolkit in order to create high-quality catalog records for music resources. (Bloom's Taxonomy: Evaluation)

#### 21st Century Skills: Digital Humanities Institute for Mid-Career Librarians

With the support of the Andrew G. #### CLA Member Profile - Learn about one of our fabulous members

#### Who are you?

I'm Penny Allen, a Canadian Librarian living and working in London, England. I graduated with a

Masters of Information Science from Leeds Metropolitan University, in 2009, now Leeds Beckett University and I also have a Library Technician Diploma from a college in Alberta. I have worked in public libraries and for a short period in a university position, which was more of a student job assisting students with computer issues, but situated in the library.

#### What do you do?

Currently I am a librarian in the Caird Library,

National Maritime Museum, London UK:. The Caird Library has one of the largest and best known maritime reference libraries in the U.K., if not the world. One of our sites is the Royal Observatory, where the Meridian Line is situated - the centre of time -UDT. I am responsible for management of the library systems, which includes Symphony, a Sirsi-Dynix product, and Aeon our online ordering system. I manage the online resources, the journal collection as well as the reproduction service we offer to the public.

I currently sit on a number of committees, two of which are family history related: <u>CILIP Local</u> <u>Studies Group</u> and the <u>CLA Local History & Genealogy Services Network</u>. In addition, I sit on two committees that are related to my position: Naval and Maritime Libraries and Archives Group (NMLAG) and <u>Museum and Libraries Group (MLAG)</u>.

#### What would be your ideal job?

My current position! This is a job to which I have aspired for many years. It encompasses research, database services as well as providing genealogy support to the public. An interesting job that I would not say no too, would be to work with the International Federation of Library Associations and Institutions (IFLA) in The Hague. I am interested to know how libraries around the world advocate, organize and present their services to their users. I am also interested in how under developed countries find ways to provide internet access, for example, through libraries in Africa and Eurasia.

#### Where do you see yourself career wise in 10 years?



In 10 years I expect to be winding down my career (perhaps gradually), as I am a life-long learner, as I suspect many librarians are. During this period I can see myself teaching library students, perhaps library technicians, the intricacies of genealogy reference service. Another option would be to join a non-profit organization that works toward improving literacy in under-developed countries especially on the European continent. Later I plan to pursue genealogy research in a professional capacity as well as on a personal basis. Ideally, I would love to live 6 months in the UK and 6 months in Canada. Your guess as to which months would be in the UK!

#### Describe what you are passionate about.

So many things! Isn't this is true of most librarians? A single thought is that I am passionate about the way in which people look at the world, and how the correct information (provided by libraries and librarians) can inform people's decisions about events in their lives.

reform to fulfill Canada's obligations under international copyright treaties and to address how copyright operates in the digital environment. Some minor amendments to the Copyright Act we made in 2004, and the Act was significantly amended in 2012, when Copyright Modernization Act was passed. The amendments discussed in this edition came into force 7 November 2012.

This second edition reflects the key changes to Canada's copyright law since 2004 that are of particular relevance to people who conduct research in the nation's libraries and archives, and to the librarians and archivists who serve them.
