Young Canada Works (YCW) summer student and graduate internship programs for 2015-2016

The Canadian Library Association in partnership with the Department of Canadian Heritage, Young Canada works program is delighted to announce that final funding decisions have been made regarding 2015-2016 applications. Our selection committee met for two days, to discuss and review all 154 (summer jobs applications) from 130 libraries, and 9 internships from 9 libraries. Organizations are ranked on financial need, the clarity of application, the heritage goals that the summer student positions (internship) fulfills, as well as, the Department of Canadian Heritage's mandate of offering students gainful employment in the heritage (library) sector.

This year, we are pleased to be able to fund 100 summer jobs and 4 internships from 10 provinces, coast to coast to coast. Decisions regarding funding of applications have now been made. We thank you for your continued support of the Young Canada Works

Where do you see yourself career wise in 10 years?


I hope that 10 years from now I will still be involved in the industry and doing something similar to what I already do but in a larger capacity.

Much has changed since the first edition of Demystifying Copyright was published in 2001. In the years that followed, the federal government embarked on a process of copyright

reform to fulfill Canada's obligations under international copyright treaties and to address how copyright operates in the digital environment. Some minor amendments to the Copyright Act we made in 2004, and the Act was significantly amended in 2012, when Copyright Modernization Act was passed. The amendments discussed in this edition came into force 7 November 2012. This second edition reflects the key changes to Canada's copyright law since 2004 that are of particular relevance to people who conduct research in the nation's libraries and archives, and to the librarians and archivists who serve them.

Public Library of the year 2015

The hunt is once again on to discover the world's best public library. In 2015, the <u>Danish</u> <u>Agency for Culture</u> will again have the honour of presenting the <u>Systematic Public Library</u> <u>of the Year Award</u> sponsored by Systematic with prize\$US 5,000. <u>Applications</u> close on 15 June 2015.

The prize will be awarded to a library that has been newly constructed or designed for a building that has not previously been used as a library during the period 1 January 2013 through 15 June 2015, and which meets the criteria for the <u>Model Programme for Public</u> Libraries.

The Award will be presented at the IFLA World Library and Information Congress in Cape Town, South Africa on 16 August in cooperation with the IFLA's <u>Public Libraries Section</u>.
