Hot Off the Press

CLA Executive Council Meets in Toronto Feb 2-3

2014 President Marie DeYoung convened the first meeting and orientation of the 2014 Executive Council on Feb 2-3 at Ryerson University following OLA. Highlights include:

- Review and approval of the 2014 Strategic Action Plan (available soon on www.cla.ca)
- Review and approval of the CLA Statement on the closure and consolidation of federal government libraries (available soon on <u>www.cla.ca</u>)
- Confirmation of the 2014 recipient of the CLA Advancement of Intellectual Freedom Award, to be presented in Toronto on Feb 25 during Freedom to Read Week and announced the week of February 10th.
- Approval of two new CLA Network: <u>Next Generation Network</u>. This brings the number of CLA networks to 25.
- Receipt of the <u>CLA Brief to the Royal Society of Canada's Expert Panel on the Future of</u> <u>Canada's Libraries and Archives</u>. CLA Treasurer Mike Ridley and Councillor Jane Schmidt presented the brief to the panel at meeting earlier in January
- Receipt of the 2013 Financial Statements (unaudited) and approval of the 2014 Budget
- Review of the program for 2014 CLA Conference in Victoria May 28 to May 31.
- Addressing the imperative to review/revise the CLA Constitution and Bylaws as required by the new Canada Not-For-Profit Corporations Act by October 17, 2014. Members will receive information prior to the AGM in Victoria May 2014.

The Executive Council meets three times for face-to-face meetings throughout the year and monthly via teleconference. Face to face meetings are open to members. There is also provision for electronic voting and decision making.

Publication of the RDA Element Vocabularies

The Joint Steering Committee for Development of RDA (JSC), Metadata Management Associates, and ALA Publishing (on behalf of the co-publishers of RDA) are pleased to announce that the RDA elements and relationship designators have been published in the Open Metadata Registry (OMR) as Resource Description Framework (RDF) element sets suitable for linked data and semantic Web applications.

The elements include versions "unconstrained" by Functional Requirements for Bibliographic Records (FRBR) and Functional Requirements for Authority Data (FRAD), the standard library models underpinning RDA, that are intended for use in applications by non-RDA communities.

The practical and the ideal are in direct competition for resources."

ACUP/APUC eBOUND

Dear Colleagues, Following a landmark partnership agreement between OCUL, the Association of Canadian University Presses/Association Des Presses Universitaires Canadiennes (ACUP/APUC), and in conjunction with eBOUND Canada, CRKN was invited to meet with eBOUND, OCUL and other regional consortia to explore how the broader Canadian library community can be involved in expanding access to Canadian scholarly monograph content within a sustainable publishing environment. The objective to expand access to Canadian digital scholarly monographic content through a collaboration with both Canadian scholarly publishers and with Scholar's Portal aligns with the objective of CRKN's strategic plan.

Within the next month, CRKN will present an offer to members for the purchase of approximately 4000 eBook titles from 13 Canadian university presses through eBOUND. The package is divided into five collections; pre-2011, 2011 and 2012, 2013, 2014 and 2015. An initial analysis found there is very little duplication with the CRKN Canadian Publisher's Collection - only 20 overlapping titles between the two packages. The agreement with OCUL members was concluded in the spirit of university libraries supporting Canadian university presses in making a successful transition to electronic publishing. CRKN is presenting this offer to our members in that same spirit to support the sustainability of Canadian university presses, while meeting the needs of library users.

In December 2013, CRKN met with representatives from eBOUND and the regional academic library consortia. At that meeting, it was agreed that CRKN was best placed to extend the offer negotiated by OCUL to the rest of Canada's academic libraries. To facilitate this partnership, OCUL's Scholars Portal has agreed to provide the hosting service (on a cost-recovery basis) on their books platform for non-OCUL libraries participating in the agreement.

As the intent of this agreement is to create a long-term relationship with publishers that facilitates a robust and sustainable Canadian scholarly publishing environment, the agreement recognizes that Canadian scholarly publishers operate in a small market, without the economies of scale that can contribute to the extremely low per-book costs their American counterparts enjoy. The comprehensive agreement ensures that the presses make the transition to e-versions of all content, creating a complete catalogue of Canadian university press scholarship for future users.

When the offer information is released in the coming days, I encourage you to review it with your collections teams. CRKN will be setting up French and English teleconferences later in February at which representatives from eBOUND will be available to answer questions. In the meantime I encourage you to direct questions to our listservs or to your OCUL colleagues. At CRKN we look forward to good uptake of this Canadian content that supports the transition of Canadian UP's to electronic publishing. I invite your feedback and questions on this exciting initiative.

University of Ottawa School of Information receives accreditation

The new UO School of Information Studies has received its first certificate of accreditation from the American Library Association Committee on Accreditation (COA) for the degree of Master of Information Studies. The certificate states in part "in recognition of meeting the Standards for Accreditation of Master's Programs in Library and Information Studies, January 26, 2014". The UO program is the only bilingual library school program in Canada.

UBC's SLAIS granted conditional accreditation

The ALA Committee on Accreditation (COA) has granted "conditional accreditation status to the program leading to the degree of Master of Library and Information Studies at the University of British Columbia (SLAIS)." The decision was made at the COA meeting on January 26, 2014 and was based on the Program Presentation, the External Review Panel Report, all of the reports the program submitted to the Committee since the last comprehensive review and the January 25, 2014 meeting with the Director of the School, Dr Caroline Haythornthwaite. The next review visit has been scheduled for the fall of 2016 at which time the school is required to demonstrate full compliance with COA accreditation standards. CLA's observer for the review process was Dr Cheryl Stenstrom. CLA wishes them well in this process.

Ottawa Public Library to add 3D printer to its collection

OTTAWA - In a bid to remain relevant, the Ottawa Public Library is bringing in a 3D printer, a laser cutter, a green screen and other technological goodies.
