3. Library and Archives Canada "Lender of Last Resort" Service

From Cecilia Muir, Chief Operating Officer, Library and Archives Canada

"On November 18, 2013, Library and Archives Canada (LAC) will implement a "lender of last resort" service, through which Canadian libraries will be able to access published materials uniquely held at LAC. This service was developed in the context of the User Roundtable convened in late 2012 and early 2013. My thanks once again to those of you who were engaged directly in this work. Your input has informed this service, and I have attached the service description as it will appear on our website.

LAC is continuing to provide access to our collections through on-site services at 395 Wellington, through digitization-on-demand services, and increasingly through our large-scale digitization initiatives, which will enable us to extend online access to high-demand material on microfilm. We are continuing to facilitate interlibrary loan activities among other institutions through ongoing administration of Canadian Library Symbols, and through the ILL form in

AMICUS. Our own approach to loans will focus on items that are unique to LAC's holdings that are not available through other institutions, through digital channels, or through paid service options.

LAC recognizes that it will be important for us to monitor and adapt our capacity over time as we determine the level of engagement in the lender of last resort service. I wanted to ensure you are aware we will be doing this, as we will need your feedback. With that in mind, I will convene a follow-up roundtable discussion in 2014 and will invite you to share thoughts on the service in progress. In the meantime, if you have any comments or questions, please feel free to be in touch with our lead in client services, Fabien Lengellé, Director General of Services (Fabien.Lengelle@bac-lac.gc.ca)."

CLA Copyright Advisory Committee Response to Notice & Notice provisions of the Copyright Modernization Act

Dear Minister Glover and Minister Moore,

Thank you for providing the Canadian Library Association with the opportunity to comment on bringing the Notice & Notice provisions of the Copyright Modernization Act into force.

CLA makes the following comments:

- Given that Search Engines have 30 days
 to respond to a notice by removing its
 cached copies of material "that has
 already been removed from the specified
 electronic location", CLA recommends that
 ISPs and hosts are required to forward any
 notice received from a copyright holder to
 its subscriber within 30 days.
- CLA strongly recommends that the government prescribe a form for each type of notice to ensure that all the required elements in a notice are actually included (as is permitted in s.41.25(2)).
