### CLA in Hill Times: Print-Disabled Community in Canada Requires Government's Support Without Delay

Michael Geist's recent article "*Why has Canada still not signed the Copyright Treaty to Support the Blind?*" (The Hill Times, June 16, p. 10) touches on a critical issue of importance to more than 600,000 Canadians.

The Canadian Library Association (CLA), along

with many other organizations and the print-disabled community in Canada, celebrated the adoption of the WIPO Marrakesh Treaty to Facilitate Access to Published Works for Persons Who Are Blind, Visually Impaired, or Otherwise Print Disabled (VIP Treaty) on June 27, 2013. The Canadian government was deservedly commended for its role in the successful completion of the negotiations.
