### 3. Urban Libraries in 2012: Under Pressure and In Demand

Big-city public libraries have rarely been as popular as they are today and rarely as besieged.

The hard economic times of recent years have generated increased demand for the free and varied services that libraries provide, even as revenue-challenged local governments have cut back on contributions to library budgets. All of this comes at a time when libraries are being asked to perform a new and changing range of functions.

Due partly to their role as society's default providers of computer and Internet access, today's urban libraries do much more than lend books and DVDs. They help city residents--including those with limited incomes and educations-find jobs, obtain health information, and get connected to government services and benefits.

In so doing, libraries are fulfilling what has been called their "shadow mandate," supporting and complementing the work of other public and quasi-public agencies. City residents have come to see libraries, particularly neighborhood branches, as multipurpose community centers, offering business services, tax assistance, safe havens for children after school, public meeting spaces, and places where immigrants can learn English. five-year term begins May 23. The announcement was made today by provost and vice-president (academic) Maureen Mancuso, who chaired the search committee.

"Rebecca possesses the knowledge, skills and qualities that we were looking for in our next CIO and chief librarian," Mancuso said. "She is a strategic thinker and an exceptional leader whose experience, vision and passion will help us further build our reputation as a forerunner in information technology and library systems."

In making the announcement, Mancuso expressed gratitude to Catherine Steeves, the University's associate chief librarian, who has been acting in the role since Mike Ridley completed his second term in January.

Mancuso also thanked members of the search committee, which included faculty, students and staff members, for their hard work and commitment, and the University community for its participation.

Most recently, Graham was the associate librarian for preservation, digitization and administrative services at Harvard College Library (HCL) in Cambridge, Massachusetts. She oversaw all administrative services and managed a \$90-million budget and 12 library buildings, and was responsible for HCL's

For the 10th anniversary of International Adult Learners' Week in Canada (IALW) 2012, the Canadian Commission for UNESCO would like to stress the urgent need to reach a broader public.

At the Sixth International Conference on Adult Education (CONFINTEA VI), in Belém, Brazil, 2009, the adoption of the Belém Framework for Action was a defining moment of the conference. The Belém Framework of Action highlight in particular that "Inclusive education is fundamental to the achievement of human, social and economic development.

By adopting "I am still learning" as its slogan, the 2012 campaign reminds everyone, no matter what their skills, of the importance of lifelong learning. The slogan was well received by ministers of education in over seven provinces and territories who have confirmed their commitment to *International Adult Learners' Week in Canada (IALW)*.

The Canadian Commission for UNESCO, together with its partners, considers International Adult Learners' Week as an opportunity to raise the awareness of a broader public about lifelong learning and the need to adapt programmes to different needs. Better synergy among stakeholders facilitates the sharing of lessons learned, as well as it giving greater visibility to learners across the country.

A message from the *Canadian Chamber of Commerce* published in *Connect* adds an economic perspective to this call for inclusion. Its states that to increase the size of its workforce, Canada will need to draw far more extensively on underutilized sources of labour within its borders. These include young people, older workers, the Aboriginal population and people with disabilities. Skill adjustment is also part of the solution.

Some new programmes linked with the recognition of prior learning and inclusion are worth mentioning:

- An Aboriginal Adult Literacy Assessment Tool is being proposed by Saskatchewan Aboriginal Literacy Network. It incorporates a culturally and linguistically relevant context for assessing work place literacy skill development as well as linking literacy to community and societal values and activities.
- The Canadian Information Centre for International Credentials has updated its website and is facilitating access to relevant information for immigrants.
- The Northwest Territories is using the week to launch an information campaign to reach out to a linguistically diverse and geographically dispersed public through a judicious use of the media, both traditional and social. This information is illustrated by true stories told by those who overcame challenges and therefore provides relevant models to help adults share their successes. Some of the messages are in Aboriginal languages.

Once again IALW provides the opportunity for productive alliances and better governance of lifelong learning programs.

The Council of Atlantic Ministers of Education and Training will use


