# Hot Off the Press

# 1. CLA appears before Senate Committee reviewing C-11

CLA was invited to appear as a witness to the Senate Committee on Banking, Trade and Commerce, which is reviewing Bill C-11, An Act to Amend the Copyright Act. We were represented by Victoria Owen, Chair of the CLA Copyright Advisory Committee and Kelly Moore, CLA Executive Director. The presentation focused on the three issues raised in the <u>technical amendments</u> <u>document</u> prepared in February for the House of Commons copyright legislative committee. Based on the questions, and conversations with some of the Senators afterwards, there is support for libraries generally and the work we do in serving the public interest.

The Senate Committee heard from Ministers Moore (Heritage) and Paradis (Industry) on 21 June. There was a full day of witnesses on 22 June (including CLA), and again on 26 June. Transcripts will be posted to the <u>CLA Copyright</u> <u>page</u> as soon as they are available.

# 2. CLA Statement on Licenses with Access Copyright in Post-Secondary Institutions

CLA has issued a Statement on Licenses with Access Copyright in Post-Secondary Institutions. The statement highlights issues for consideration by institutions in determining whether they will sign a license. CLA urges administrators of post-secondary institutions to involve their academic librarians in exploring alternatives, and to develop strategies that reduce reliance on blanket licensing.

#### Did You Know...

The Globe Theater, where most of Shakespeare's plays debuted, burned down on this day in 1613?

The Globe was built by Shakespeare's acting company, the Lord Chamberlain's Men, in 1599 from the timbers of London's verv first permanent theater, Burbage's Theater, built in 1576. Before James Burbage built his theater, plays and dramatic performances were ad hoc affairs, performed on street corners and in the yards of inns. However, the Common Council of London, in 1574, started licensing theatrical pieces performed in inn yards within the city limits. To escape the restriction, actor James Burbage built his own theater on land he leased outside the city limits. When Burbage's lease ran out, the Lord Chamberlain's men moved the timbers to a new location and created the Globe, Like other theaters of its time, the Globe was a round wooden structure with a stage at one end, and covered balconies for the gentry. The galleries could seat about 1,000 people, with room for another 2.000

#### New Parliamentary Librarian Appointed

CLA offers congratulations to Canada's new Parliamentary Librarian, Sonia L'Heureux, who was appointed on 22 June.

Ms. L'Heureux joined the Library of Parliament in 2008 as Assistant Parliamentary Librarian. Since February 2012, she has held the position of Associate Parliamentary Librarian and has been performing the duties and functions of Parliamentary Librarian since that time. She is also a member of the Standing Committee on the Library and Research Services for Parliament section of the International Federation of Library Associations and Institutions.

Prior to joining the Library of Parliament, she held the positions of Director General of Reorganization Implementation and Renewal Integration at Human Resources and Social Development Canada and Specialist Advisor, Tax Policy, at the Australian Treasury. She has also worked as a policy analyst at Finance Canada, Environment Canada and Energy, Mines and Resources Canada.

Ms. L'Heureux holds a Master of Science in Economics and a Bachelor of Science in Economics from the Université de Montréal.

Holding a special place in Canadian history, the Library of Parliament is the last remaining part of the original Parliament building. It is a fully functioning library whose collection and services support the activities and decisions of Parliament. The control and management of the Library rests with the Parliamentary Librarian, who is appointed by the Governor in Council.
