2. World Press Freedom Day 3 May

(i) UNESCO celebrates World Press Freedom Day in Costa Rica "Safe to Speak: Securing Freedom of Expression in All Media"

Almost every week, UNESCO marks the death of yet another journalist killed because of his or her professional activity. This tragic tally casts a long shadow on press freedom, which UNESCO celebrates annually on 3 May. The main event for this year's World Press Freedom Day will be held from 2 to 4 May in Costa Rica, with an international conference on the theme "Safe to Speak: Securing Freedom of Expression in All Media".

The event also includes the award ceremony for the UNESCO-Guillermo Cano World Press Freedom Prize. The 2013 laureate is Ethiopian journalist **Reeyot Alemu**, who is serving a five-year jail sentenced in Ethiopia's Kality prison. UNESCO Director-General Irina Bokova and the President of Costa Rica, Laura Chinchilla, will preside over the ceremony on 3 May (9a.m. to 10.30 a.m.). More here>>

Library and Information in Germany (Bibliothek & Information Deutschland: BID), the umbrella organization for German library associations, has issued a statement of support for Dale Askey, and requesting that the Edwin Mellen Press withdraw its legal action against him.

8. The Parliament of Canada issued a call for nominations to begin the search for Canada's sixth Parliamentary Poet Laureate.

The role of the Parliamentary Poet Laureate is to promote the importance and value of poetry among all Canadians. Pursuant to the Parliament of Canada Act, the Poet Laureate may perform the following duties: compose poetry, including for use in Parliament on occasions of state, sponsor poetry readings, advise the Parliamentary Librarian on the Library's collection and acquisitions to enrich the collection's cultural holdings, and perform related duties at the request of the Speaker of the Senate or the Speaker of the House of Commons, or the Parliamentary Librarian. The Poet Laureate holds office for a maximum of two years.

The deadline for nominations is July 3, 2013. Nominations will be reviewed by a selection committee, chaired by the Parliamentary Librarian. Following, the names of three candidates will be presented to the Honourable Noël A. Kinsella, Speaker of the Senate, and the Honourable Andrew Scheer, Speaker of the House of Commons, for final selection. The new Poet Laureate will be named in December 2013 to coincide with the end of the term of the present Poet Laureate.

Victoria Owen receives Robert H. Blackburn Distinguished Paper Award

CLA is pleased to award Victoria Owen (Head Librarian, University

of Toronto Scarborough) the 2013 Robert H. Blackburn Distinguished Paper Award for her 2012 paper entitled, "Who Safeguards the Public Interest in Copyright in Canada," published in Journal of the Copyright Society of the USA (59:4, Summer 2012).

Owen's paper anticipates a shift in the balance inherent in copyright between the rights of copyright holders and those of users. The paper highlights the significant role public sector institutions play in advancing the public interest. Public sector educational institutions (kindergarten to grade twelve and at the post-secondary level) are facing a fundamental shift as licenses for reproduction are being phased out and replaced with a tariff. This has broad implications for libraries and their users' rights.
