#### 1. CLA 2013 Election Candidates for Executive Council

At the 2013 CLA AGM in Winnipeg, Karen Adams, Chair of the Nominations Committee, announced the candidates for this year's CLA election for Executive Council. There are four vacancies to be filled: for Vice-President/President-Elect, for Treasurer, and for two Councillors-at-Large. We are very pleased that there are strong slates of candidates for both positions.

- Candidates for President: Kathleen DeLong, Jan Harder, and Sandra Singh;
- Candidate for Treasurer: Mike Ridley;
- Candidates for Councillors: Virginia Clevette, Lorna Rourke, and Marc Truitt.

As the position of Treasurer has only one candidate at this time, we will be opening nominations for this position to petition by members. Petitions must be supported by at least 5 personal members of CLA, and should be submitted to Kelly Moore, CLA Executive Director, no later than 15 July.

### Bylaw 4.2.5 states:

If the Nominations Committee receives only one nomination for a vacancy by the deadline for nominations, the name of the nominee shall be presented to the membership at the Annual General Meeting. Further nominations may be entered by petition of five personal members and shall be filed with the Executive Director no later than 15 July. If, as of 15 July – "Nomination Day" – there remains only one nominee, the nominee shall be declared elected.


CLA thanks each of the candidates for their commitment to serving our association. Look for candidate statements and profiles to be posted on the CLA website next week.

CLA Executive Council has today sent a letter to Heritage Minister James Moore indicating support for the proposed Heritage Project developed by Library and Archives Canada in partnership with Canadiana.org, and urging the Minister to give his support to the project.
