At the Business Meeting (2004) the implementation of the CLA Resolutions re: Native Peoples proposed by Jim Bruce and passed at the CLA AGM 2002 was discussed. The IG proposed the development of First Nations/Aboriginal recruitment and public education materials about LIS services and career options as a first step. An application for Special Project Funds has been submitted to CLA requesting \$3500.00 to develop and produce recruitment materials (brochure and website content). The proposal supports CLA's commitment to diversity and its recognition that "effective advocacy is based upon understanding the social, cultural, political and historical contexts in which libraries and information services function."
