2015 Federal Election

The much anticipated 2015 Federal Election was formally announced on Sunday, August 2nd during the high point of Canadian summer. The election call formalizes what has already been a campaign-like environment, as the political parties prepared for the pre-set election date of October 19, 2015.

This election period is surprising in that it is the longest-running election campaign since the Victorian Era and modern voting. The 78-day campaign will be almost twice as long as the average previous campaign periods.

CLA had an existing election strategy in place and was well prepared for the early election call. There has been incredible action on the part of many committees to identify the CLA membership's priorities and to create a communication strategy to target candidates in this very important federal transition period. As such, the association will be launching several key election-related advocacy tools very soon, including:

- A federal election website for library related issues. The membership previously identified the following priorities in an election context:
 - Copyright issues
 - Support to reinstate the Long Form Census
 - Broader Support for Library and Archives Canada
- A personalized web based contact program for members to lobby candidates (an election widget)

CLA and members of the various committees who support CLA will also be monitoring election activity for related issues and updating members as needed.

In the coming days, members will be hearing more about how you can become involved in the election process and we look forward to engaging you in our election grassroots advocacy. Stay tuned for these exciting opportunities!

The Canadian Library Association Supports the Tri-Agency Statement of Principles on Digital Data Management

The Canadian Library Association welcomes the intent and desired impact of the draft [Tri-Agency Statement of Principles on Digital Data Management](#) to create "a robust and open research data environment in Canada".

The [Canadian Institutes of Health Research \(CIHR\)](#), the [Natural Sciences and Engineering Research Council of Canada \(NSERC\)](#) and the [Social Sciences and](#)

[Humanities Research Council of Canada \(SSHRC\)](#) (the Tri-Agencies) provide significant public funds to advance research in Canada.

Libraries across Canada are portals for Canadian from all walks of life to access and utilize the research data gathered through federally sponsored projects. These data can provide leverage for education, innovation, community development and a vast array of other positive results.

For too long these data were either unavailable or restricted to members of the academic community. The intent of this statement to make such data accessible to all Canadians will maximize the value of Canada's research investments and infrastructure.

Coupled with the Tri-Agency Open Access Policy on Research Publications, the draft statement advances a widespread regime of open access and open data, a public asset long advocated for by the Canadian Library Association.

ALCTS Web Course: Fundamentals of Collection Assessment

This session will look at libraries as "publishers" and what that role really entails? What can library publishers do that we cannot get from monster publishing houses or university presses? While some schools cite challenges in motivating authors to contribute large scale works to open access collections, there are many positive opportunities which can be identified for libraries to address - areas where publishers have historically struggled. 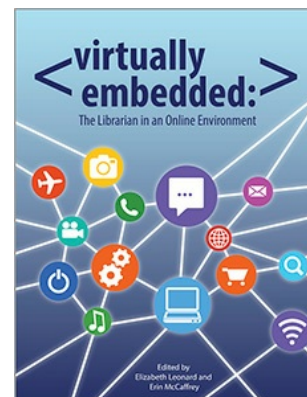
Virtually Embedded: The Librarian in an Online Environment

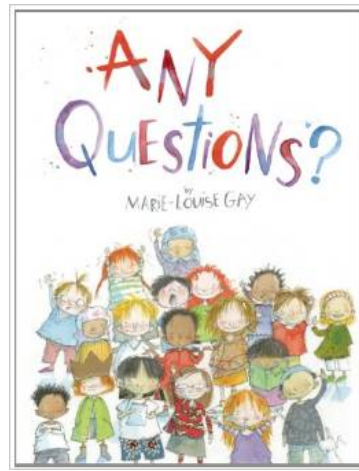

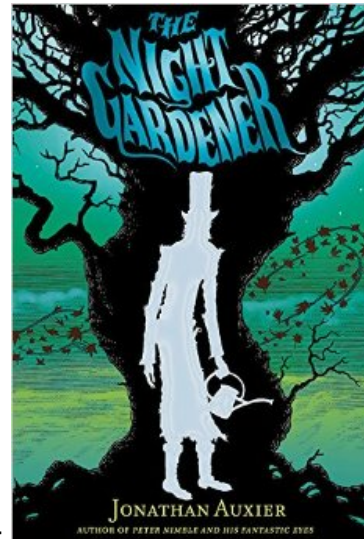

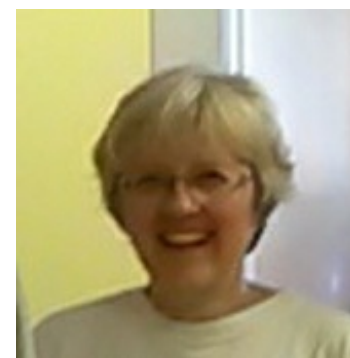

Member Updates

Learn about one of our fabulous members

Who are you and where are you from:

My name is Carol Rigby, and where I'm from is a good question. My parents are East Coasters who were missionaries in Africa, so I moved around a lot growing up. I collected two university degrees and a geographer husband in Ottawa in the '70s and '80s, and in 1986 our young family moved to Baffin Island in the Canadian Arctic. Twenty-five years later he retired from the Nunavut public service, our younger son took over the Iqaluit family home, and we moved to our "cottage" on Lanark County waterfront, about an hour west of Ottawa. I now work from home, near Maberly, but still have office and work connections to Iqaluit, Nunavut.



What do you do:

I am a self-employed technical services librarian and professional editor, working on contract for a number of different clients. My primary contract is providing cataloguing services for the Nunavut Legislative Library, as I have developed a niche specialty in creating original bibliographic records for multilingual, multiscript and northern materials. I have been working for the last 10 years in the Nunavut library community on developing and implementing bibliographic cataloguing standards for materials in Inuit languages, including Inuktitut syllabics. Over that period, everybody in the CLA Technical Services Network has heard me grump, grumble and question about the anglo-centricity of cataloguing rules and approaches! Other clients for whom I provide the same services include Nunavut Public Library Services and the Pond Inlet Library and Archives Society.

When not doing contract work, I'm a busy library volunteer. I sit as a trustee for Tay Valley Township on the Perth and District Union Library Board, chairing their policy committee, and also currently serve as Moderator for CLA's Trustee Network. Besides being a member of CLA, I belong to the Nunavut Library Association and manage the NLA website. Recently (and probably due to the aforementioned grumbling to TSN folks) I have also been appointed as a "co-opted" (i.e. non-voting, advisory) member to the Canadian Committee on Metadata Exchange (CCM), where I hope to provide a voice for small, rural and remote libraries and their users when it comes to catalogue coding issues.

What would be your ideal job:

My ideal job is the one I have now-it's small, unique, and infinitely flexible. I get to choose how much work I want to take on, and frequently have new and interesting projects thrown at me. Because I work in original cataloguing, I frequently end up developing new policies and procedures to help out my clients, and the northern material that I catalogue is always interesting and often unique. I've taught myself how to type in Inuktitut syllabics and learned about the evolving world of metadata as I have helped the very small systems I work with understand and adopt new developments in cataloguing standards.

Where do you see yourself career wise in 10 years:

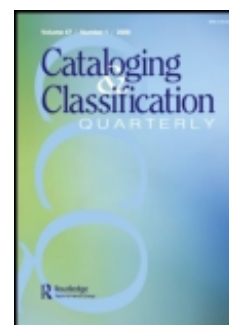
I see myself as the Yoda of the Inuktitut cataloguing world.... In 10 years I could be well into retirement, but if anyone out there were to want help with cataloguing Inuktitut language materials in Inuktitut, I could see myself working on special projects for years to come. I also hope in 10 years to be looking at a bigger or renovated facility for the Perth & District Union Library-my personal trustee advocacy goal for that period.

Describe what you are passionate about:

I'm passionate about the critical role of libraries in building communities, particularly small libraries and those in rural and remote locations. These spaces and their resources are essential lifelines for people who may not have access to materials, technology and information that most of us take for granted. I've worked in school, public and special libraries, and all have important roles in educating, informing, and providing welcoming, safe spaces for people to meet and to help each other. I'm also passionate about the quality of information that goes into the data systems that so many of us give no thought to-data should be provided in a way that makes information equally accessible to everyone, including Canada's aboriginal peoples.

Libraries, publishers take new approach to ebook buying in Atlantic collection deal

Nova Scotia's public libraries and the Atlantic Publishers Marketing Association broke new ground in ebook collection development in a project announced Wednesday in Halifax.

Nova Scotia Regional Libraries and Halifax Public Library have together purchased a selection of over 600 copies of Atlantic-published ebooks. The books are available starting in August in a "Read Local" collection for library users. Outside of Quebec, this is the first

IFLA School Library Guidelines, 2nd edition

The IFLA School Library Guidelines, 2nd edition, was endorsed by the Professional Committee on advice by the Committee of Standards in June 2015. The standard was revised and written by the School Libraries Section over a period of more than two years and replaces the IFLA/UNESCO School Library Guidelines which were published in 2002.

The guidelines have been developed to assist school library professionals and educational decision-makers in their efforts to ensure that all students and teachers have access to effective school library programs and services, delivered by qualified school library personnel.

The drafting of these revised guidelines involved input and discussion at various workshops, events and meetings, some of which received funding support from the IFLA Professional Committee, and through ongoing writing and review in person and online.

In August 2015 after more than three years of negotiations and intense involvement from many stakeholders, including IFLA, the Member States of the United Nations agreed to the final version of the post-2015 Development Agenda, now known as Transforming our world: the 2030 Agenda for Sustainable Development. The 2030 Agenda succeeds the Millennium Development Goals and is a framework of 17 Sustainable Development Goals (SDGs) with a total of 179 Targets spanning economic, environmental and social development.

By early October 2015, IFLA will develop a booklet about the role of libraries and the 2030 Agenda.

This booklet will:

- * Raise the profile of the contribution libraries make across the 2030 Agenda and the SDGs;
- * Support capacity building of libraries and library associations in their advocacy to include libraries, access to information, ICT and culture in national development plans.

The format of the booklet will include:

- * An overview of the 2030 Agenda and each of the 17 Sustainable Development Goals;
- * Examples, impact and pictures of library programmes and services that contribute to specified targets;
- * Suggestions for policymakers on what libraries can contribute in meeting the Goals.

IFLA is calling for examples to be added to the libraries and the 2030 Agenda booklet to ensure that the booklet represents the scope of the library and information services profession in all regions, library types and at all levels.
